

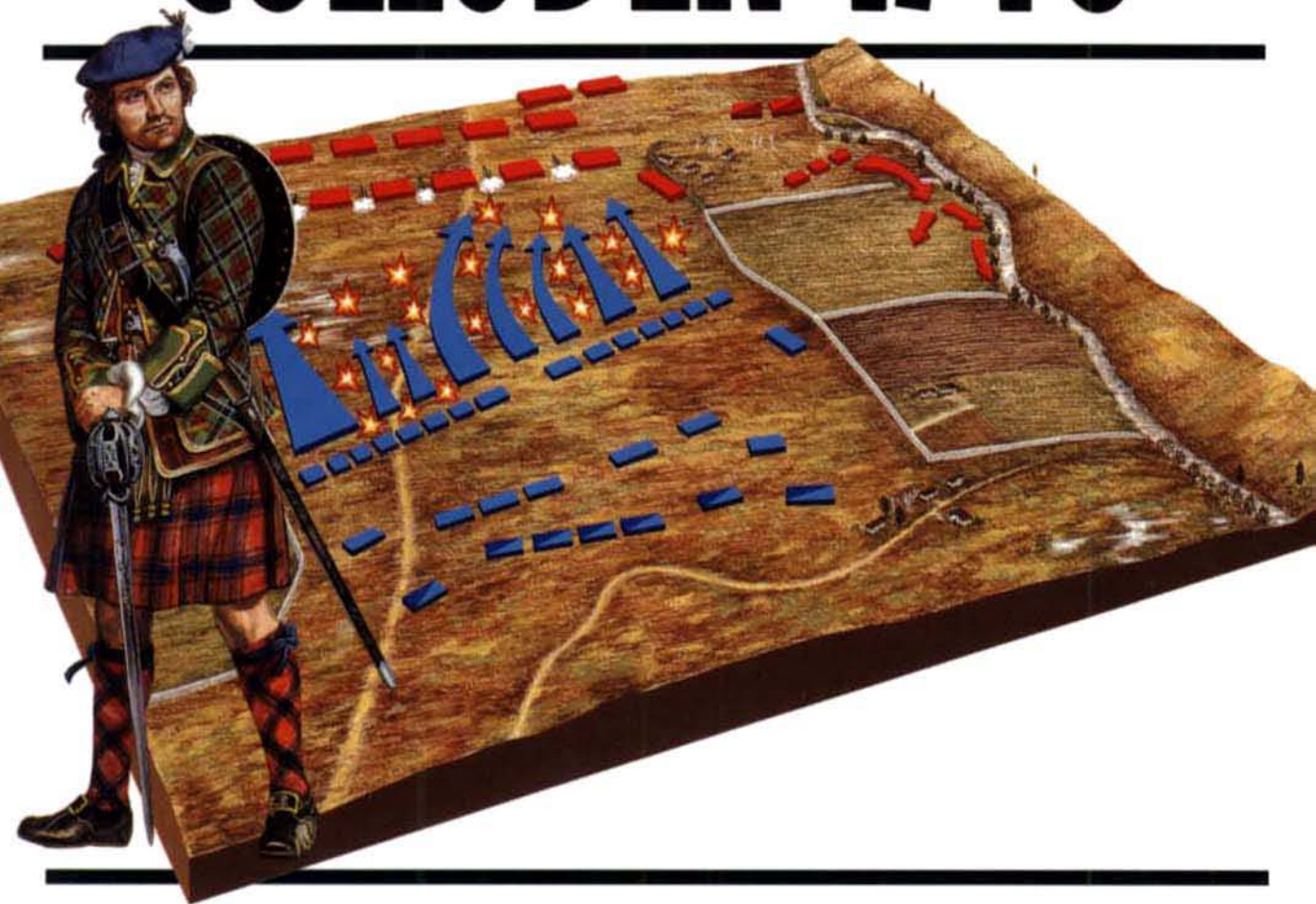

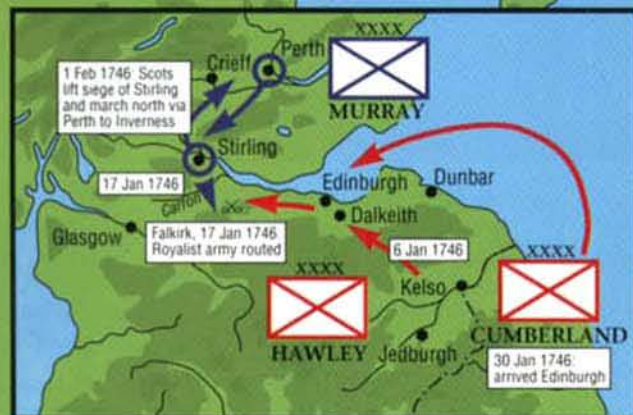

The March of the Jacobite Army, 1745



Falkirk Phase, January 1746



BACKGROUND TO THE 'FORTY-FIVE'

On 16 July 1745, Prince Charles Edward Stuart and a handful of supporters, known as the 'Seven Men of Moidart', with a small quantity of arms and ammunition, set sail from Brest aboard two small French frigates, *Du Teillay* and *Elizabeth*, bound for the small Hebridean island of Eriskay. After a brief run-in with the Royal Navy's HMS *Lion*, *Elizabeth* was damaged and had to return to France. With her went most of the military stores and a number of French volunteers. Undeterred, Charles landed on Eriskay, to be met by Alexander Macdonald of Boisdale who advised him to return to the continent. 'The Prince would have none of it; 'I am come home, sir,' he replied. He reached the mainland of Scotland, at Loch nan Uamh near Arisaig, on 25 July and three weeks later, having solicited support from among the Highland chiefs, he raised his standard at Glenfinnan on 19 August, at which time his father was proclaimed James VIII of Scotland and III of England, and the Prince, his successor.

The 1,200 men who were present at Glenfinnan saw Charles as the rightful heir to the thrones of England and Scotland. It had been more than fifty years since a Stuart had ruled Great Britain, but since the 'Glorious Revolution' of 1688 both countries had been led by Protestant claimants from the continent, beginning with William of Orange and his wife Mary. Being forced to flee, James II found sanctuary in France, and an enthusiastic supporter in Louis XIV, the old enemy of William, who saw in his English fugitive an opportunity to gain revenge for his defeats at the hands of the Dutchman. In Britain James's followers, known as Jacobites from the Latin name for James, planned to restore their rightful leader and it was left to John Graham of Claverhouse, Viscount Dundee, to lead a revolt in 1689, but his death following the successful victory over English troops at the Pass of Killiecrankie on

27 July left the Jacobite cause leaderless. James was forced to remain in exile where he died in 1701. His son was proclaimed King James VIII of Scotland and III of England in absentia. The 13-year-old was now the claimant, or pretender, to the throne, but the 'Old Pretender' had to wait his chance.

It was not all woe for the Jacobites, however. In 1702 William died, having been thrown from his horse, to be succeeded by James's younger daughter Anne, sister to Mary. William had been unpopular among Catholics in both kingdoms, particularly in the Scottish Highlands. Yet for six years James and his supporters dallied – while making plans for a military confrontation. Finally, with 6,000 French troops aboard thirty vessels, the 'Old Pretender' sailed, but was forced to return to Dunkirk by the Royal Navy. It was to be another seven years before the next enterprise, this time led by James's confederate in Scotland, the Earl of Mar, who raised the Royal Standard at Braemar in September 1715, thereby initiating what popularly became known as the 'Fifteen' Rebellion. This was better planned than previous attempts and the Jacobite forces – 10,000 men – actually brought the army of the new English king, George I, to battle. Sheriffmuir, fought on 13 November 1715, proved inconclusive, however, and the Jacobites were forced to retreat. On the previous day at Preston in northern England the Jacobites had gained a tactical victory, but failed to follow it up due to confusion and dissent among the various leaders. Unaware of the outcome, James himself had landed in Aberdeenshire, but was forced – together with the disillusioned Mar – to re-embark in February 1716 for France, where the Pretender would spend the rest of his days. A brief and feeble attempt at another adventure, this time with Spanish help, came to grief in the Pass of Glenshiel in June 1719, where Jacobite and

Spanish soldiers were no match for the English troops from the garrison at Inverness. Acutely aware of the Jacobite intentions in Scotland to stage a *coup*, and determined to subdue any uprising, the government at Westminster ordered Field Marshal George Wade to establish a chain of strategically sited forts that were linked by military roads.

For twenty-five years the English garrisons policed the Highlands successfully. Unbeknown to them, however, were the various schemes being hatched for a new attempt to overthrow the King. The Westminster government was already embroiled in a war with Spain when, in 1743, the French developed plans for an invasion which would link up with a Jacobite force assembled in

the western Highlands. A second force under Marshal Saxe and Prince Charles Edward was to land on the south coast of England within striking distance of London, but many of the French transports were wrecked or badly damaged by a gale which hit the French fleet off Brest in March 1744. It had been a half-hearted escapade by the French and the disaster gave them a suitable excuse to withdraw from the venture leaving Charles without his major ally. Undaunted, he decided that the rebellion must come from within and instructed his supporters in Scotland to make plans for his arrival in June 1745. They did not share the Prince's optimism, and feared that the loss of French assistance would doom any uprising from the start.

Shortly afterwards, he became commander of His Majesty's Forces in Scotland and superintended the construction of military roads and bridges. He was popular despite having had to disarm the Highlands. The work was commenced in 1726 using 500 soldiers and was well advanced by 1729. 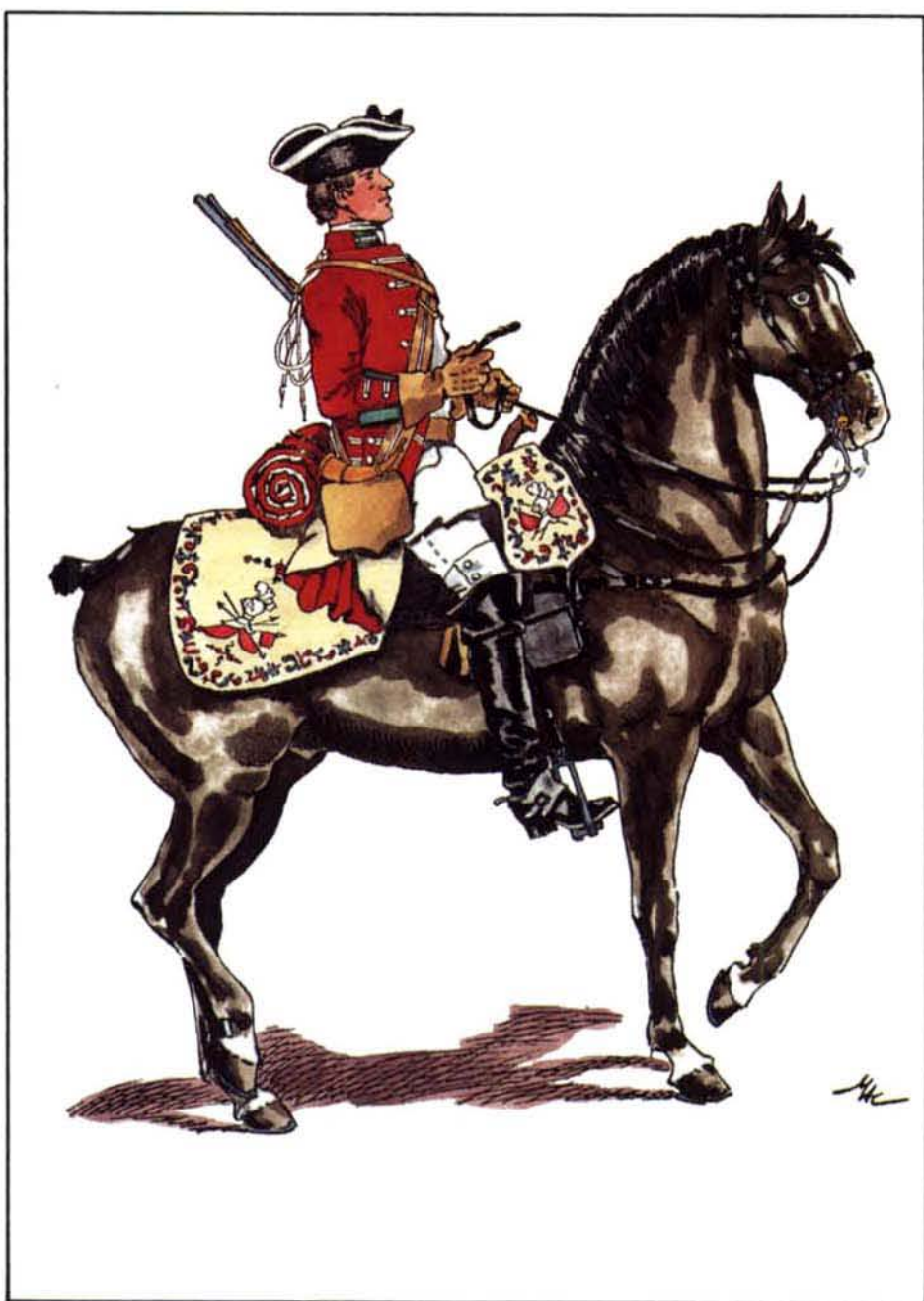


Opening Movements

Letters and appeals dissuading the Prince from his scheme fell on deaf ears and he duly landed in July. The events at Glenfinnan stirred many men who began to feel that the rising might be possible after all. The nucleus of the Jacobite army numbered about 1,300 men, none of whom, with the exception of one or two officers, had ever

experienced military service let alone warfare. Fortunately for them, the Government could bring little to bear against this raw force as it had let the strengths of the garrisons fall short of the original numbers, and could only muster about 3,000 men, including invalids who were garrisoning several castles. Sir John Cope had the unenviable task of commanding this weak force and putting down the rebellion. He should have concentrated his force

at Stirling protected by the Firth of Forth, but instead he was advised by his superiors to make his base at Fort Augustus. Intelligence on the movements of Charles and rumours of a French invasion, however, led Cope to alter his plans and he moved to Inverness on 29 August.

The Highland army was allowed free range across central Scotland and they took advantage of Cope's absence to attack the Government depot at Ruthven. Actually, the first contact between the two sides occurred earlier, on 16 August when two companies of recruits of the Royal Scots, stationed at Perth, moved to strengthen Fort William. At Highbridge, spanning the River Spean on the road from Fort William to Fort Augustus, Macdonald of Tiendrish, with a dozen men and a piper, drove the Royal troops into retreat without a fight. The

Highlanders captured the small force shortly afterwards. The main part of the Jacobite army moved towards Edinburgh and occupied the Scottish capital.

The Battle of Prestonpans

When Cope received this news he embarked his troops at Aberdeen and landed at Dunbar. The Highlanders moved out to meet them and on 21 September the two armies came face to face. Cope was satisfied with the terrain: 'There is not in the whole of the ground between Edinburgh and Dunbar, a better Spot for both Horse and Foot to act upon,' he said. With his position behind a marsh and ditch with the sea to his rear and dragoon regiments upon each flank, with infantry

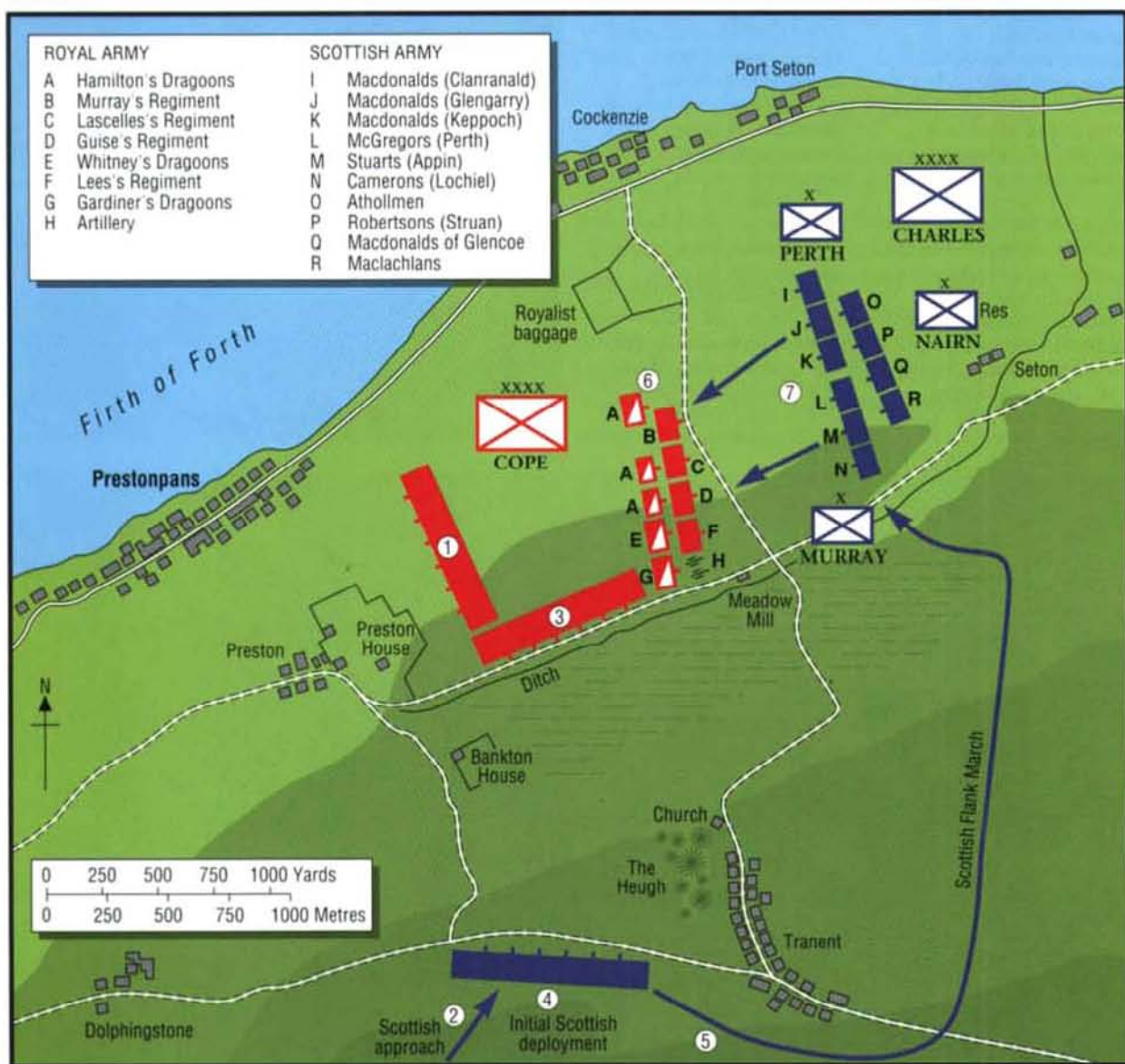

The Battle of Prestonpans, 21 September 1745



- On 20 September 1745, Cope's Government army initially deploys facing west, expecting the Jacobites to approach from the direction of Edinburgh.
- The Jacobite army, led by Lord George Murray, approaches from a more southerly direction than anticipated by Cope.
- The Government army redeploys facing south.
- The Jacobite deploy, but reconnaissance indicates that an attack across the marsh and ditch (albeit downhill) in front of Cope's army would be impracticable.
- Disagreement over what to do next leads the Jacobites to send a detachment west and then recall it; and finally the decision is taken to continue to the right and attack Cope from the east.
- Several changes of front during the evening and night end with Cope's army turned to meet an attack from the new position taken up by the Jacobites.
- At dawn the Jacobites attack.

in the middle, Cope waited for the enemy to make their move. After various flanking movements both sides found that their left wings were outflanked by their opponents' right. Soon both wings of the Prince's army, 2,500 men massed in dense columns, moved towards the Royal lines. The charging Highlanders to the front and right were too much for the Government artillerymen who quickly took to their heels. The Royal dragoons were similarly ineffective and the infantry only managed to fire one volley before they too ran away. Cope tried in vain to rally his men, but was forced to flee at the head of four hundred stragglers to Berwick-on-Tweed, leaving behind 500 dead, more than 1,000 prisoners and many wounded. His victory, achieved in just over five minutes, so impressed Charles that he began to consider his army invincible. The French too began to pay closer attention, feeling perhaps that the Prince might be able to do their work for them.

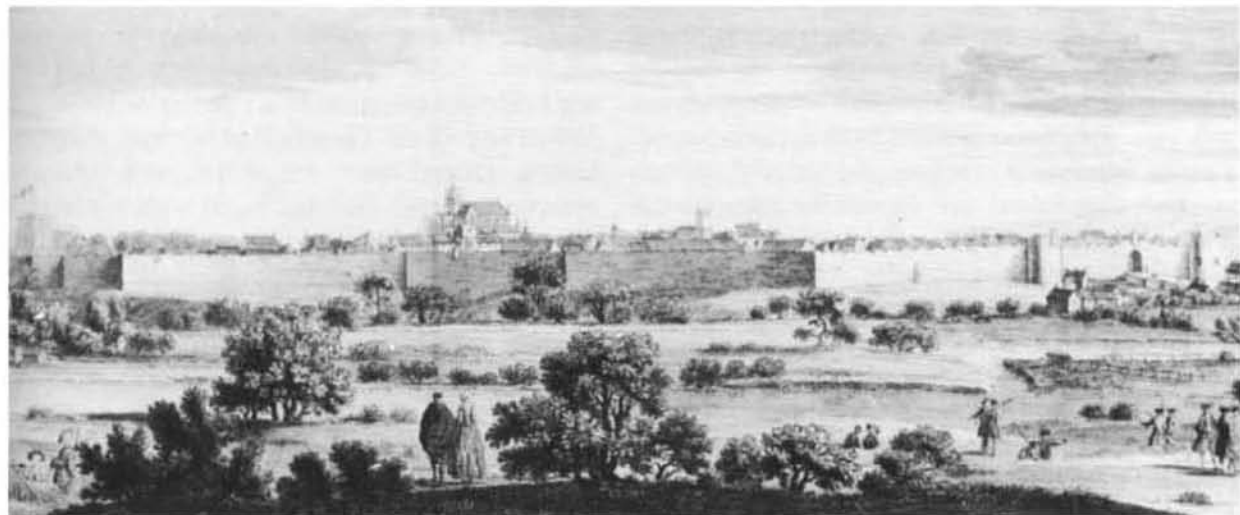

conditions were: 'All the terms his R. Highness will or can grant to the rebel garrison of Carlisle are – That they shall not be put to the sword, but be reserved for the King's pleasure.' (Anne S. K. Brown Military Collection, Brown University)

Upon news of the defeat the Government recalled ten battalions from Flanders and began to recruit more men. This was a popular move throughout England and loyal associations sprang up, offering men and money to thwart any Jacobite incursions. Scotland was now virtually under the control of Prince Charles save for a few outlying garrisons holed-up in the castles at Edinburgh, Dunbarton and Stirling. The English marchlands prepared for an emergency and the inhabitants of Carlisle assumed a defensive posture and began to build breastworks, but the place was still highly vulnerable. On 9 November, Charles's clansmen appeared before the city.

The Invasion of England

Refusing entry to the Highland army, the guns of Carlisle castle opened up. Hearing a false report of English troops fast approaching, Charles moved his army away but returned shortly after to resume siege operations. This was too much for the citizens who forced Lieutenant-Colonel Durand under protest to move his small garrison of invalid officers into the castle, but faced with the threat from the Prince that the inhabitants would be put to the sword and the town torched if the castle did not surrender, Durand capitulated. Field Marshal Wade's movement from Newcastle in an attempt to relieve Carlisle came to nothing owing to poor weather. Nothing appeared to stand in the way of the Jacobites as they quit Carlisle and moved





southwards in late November 1745, but not until they reached Preston did they encounter any enthusiasm from the local population – although few local men came forward to volunteer. Manchester saw the largest welcome laid at the feet of the Prince. Bonfires were lighted and bells were rung in his honour, but, again, few men came forward to offer their services. Those few that did – mainly unemployed labourers – were formed with other English volunteers by Francis Towneley into the 'Manchester Regiment'.

The absence of any opposition inspired the Pretender to press on. The local militia had failed to make an appearance and General Wade's columns were still moving slowly down through Yorkshire. However, Charles quickly learned that the Duke of Cumberland, the King's son and successor to Lord Ligonier as commander of the main Royal army, was massing his force of 2,000 horse and 8,250 foot in Staffordshire to threaten any movement towards Derby and the London

road. The Jacobites made a cunning feint towards Wales and drew Cumberland in that direction, leaving Derby open. On 4 December Charles entered the town but was faced with a dilemma. Cumberland, being so close, would detect the ruse and could soon be at Stafford. In the east Wade was making good time and would soon join up with the new army being formed in London. A total of 30,000 could then be brought to bear against the 5,000 clansmen who were now more than a hundred miles from their homeland.

While Charles and his staff were pondering their next move, the morale in the Jacobite army

could not have been higher, but the soldiers were unaware of the decisions being made in the War Council. Lord George Murray was for an immediate retreat, but the Prince wanted to continue the advance towards London. To back his case, he presented news of Lord Drummond's arrival in Scotland with French backing, but many felt that this would be of no use to the Jacobites in England. After much debate Charles reluctantly agreed to a withdrawal back to Scotland. Two days after entering Derby the retreat northwards began. Despite rumours that the army was moving to attack Wade and join with the French troops under Drummond, the clansmen were despondent. They had come so close to achieving their goal and now it was all for naught.

The retreat was followed closely by Cumberland with cavalry and dragoons and he was now within two days of striking the Scots. By the time the Jacobites were into Westmorland their artillery and ammunition wagons had fallen a long way behind. In the rear were Glengarry's men who were joined on the Shap fells by John Roy Stewart. Near the village of Shap, the clansmen were aware of enemy movements. A group of government mounted militia approached but moved off when threatened. At nearby Clifton a brief action took place in the village lanes between Cumberland's dragoons and some of the Jacobite cavalry, followed shortly by an advance of three dismounted dragoon regiments against the Jacobite rearguard. Hand-to-hand fighting broke out and the Royal troops were forced to break off the engagement, allowing the Jacobite retreat to proceed unchecked. Cumberland was forced to halt his exhausted troops in the wintery weather that was sweeping down over the fells. On 20 December, two days after Clifton, the Scottish army crossed into Scotland.

The Campaign of Falkirk

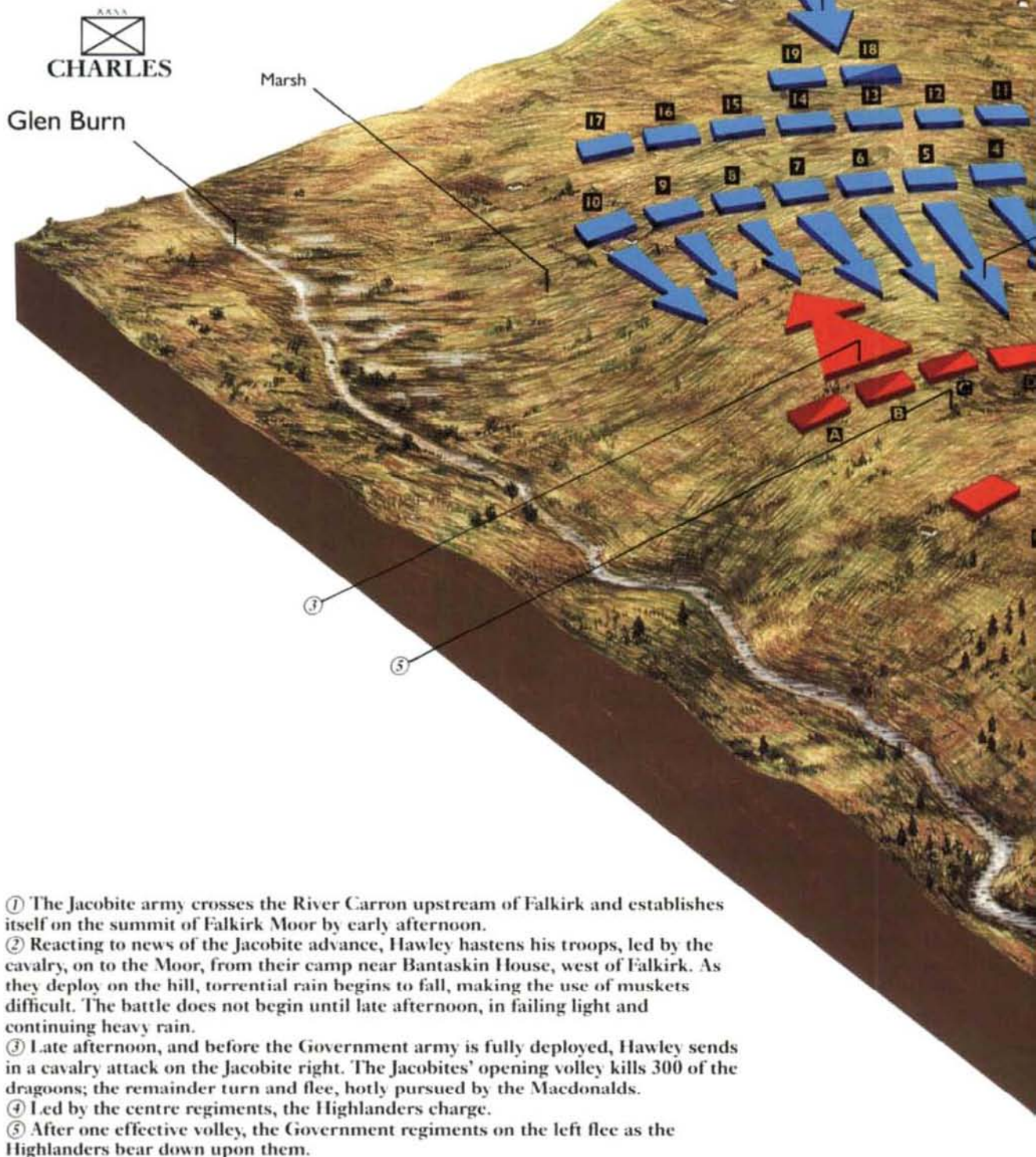
Safely back in Scotland, Charles's force grew in numbers with the addition of further clans under Lord Strathallan and Drummond's 750 Irish troops in the service of France. The task of dispersing the Jacobite army now fell squarely upon the shoulders of Lieutenant-General Henry

Hawley, brought in to replace Cumberland who had been called back to London to prepare the capital for an anticipated French invasion. Edinburgh, Stirling Castle, the Highland forts and Inverness had already been occupied by Royal troops and independent companies during the Jacobite foray into England, and the Scottish capital served as the staging-post for the next phase of offensive operations. The Jacobites were massing at Perth and in January 1746, with the train of artillery which Drummond had brought from France, began the siege of Stirling Castle, despite the fact that the height of the castle above the surrounding land made it virtually impossible to find suitable positions for siting the batteries.

Hawley arrived at Edinburgh on 6 January and began to gather his army of twelve regiments, some having recently landed from Flanders. His Achilles' heel was the artillery, a strange array of weapons taken from Edinburgh castle and manned by a motley band of country artisans. Ten days later, Hawley with his force of 8,000 men was at Falkirk in an attempt to raise the siege at Stirling. Lord George Murray was aware of this threat and on the previous day had moved the Jacobite army, 9,000 strong, to Plean Moor, two miles from the village of Bannockburn within sight of Stirling Castle where 1,000 Highlanders remained in the trenches. On the 17th the Jacobites moved off in two columns, unbeknown to Hawley who was having breakfast at Callander House with the Countess of Kilmarnock. Not until afternoon did he realize the gravity of the situation after the Jacobites had moved to occupy the hill above Falkirk. He immediately ordered his troops on to the ridge where they arrived as the weather broke. Rain began to soak the opposing forces as they deployed facing one another. The Royal infantry were in two lines of six regiments with the dragoons on the left, and no sooner had the infantry formed up than Hawley sent forward his cavalry against the Jacobite right wing. This was immediately neutralized by a Highland volley which brought down eighty horsemen. This was too much for the survivors who turned their mounts and fled headlong right into their own infantry on the left wing. The torrential rain having soaked the cartridges of their muskets, the clans-

THE BATTLE OF FALKIRK

Late afternoon of 17 January 1746



① The Jacobite army crosses the River Carron upstream of Falkirk and establishes itself on the summit of Falkirk Moor by early afternoon.

② Reacting to news of the Jacobite advance, Hawley hastens his troops, led by the cavalry, on to the Moor, from their camp near Bantaskin House, west of Falkirk. As they deploy on the hill, torrential rain begins to fall, making the use of muskets difficult. The battle does not begin until late afternoon, in failing light and continuing heavy rain.

③ Late afternoon, and before the Government army is fully deployed, Hawley sends in a cavalry attack on the Jacobite right. The Jacobites' opening volley kills 300 of the dragoons; the remainder turn and flee, hotly pursued by the Macdonalds.

⑤ After one effective volley, the Government regiments on the left flee as the Highlanders bear down upon them.

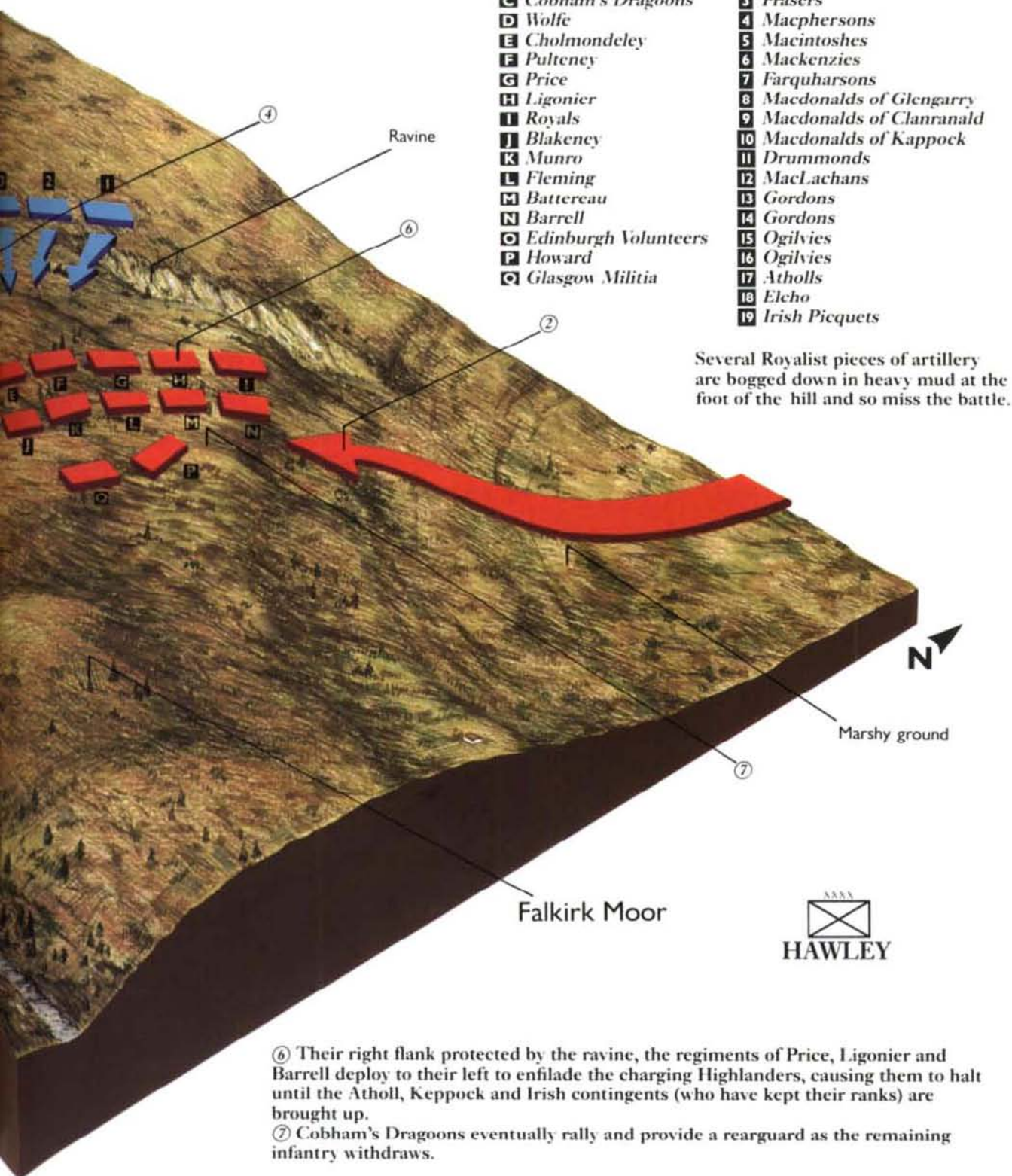

men in the centre charged with their swords. Their opponents fired one haphazard volley and then took to their heels. Had it not been for the enfilading fire from three regiments on the government right, the outcome would have been much worse, but they too were eventually forced to quit the hill in the direction of Linlithgow. Three guns from Hawley's artillery, which had been stuck in a bog and saw no part in the action, were salvaged but the other guns fell into the hands of the Jacobites. A total of 300 Royal troops were captured and a further 350 lay dying on the rain-soaked hill. For their part the Prince's army lost 50 dead and 80 wounded. The twenty-minute battle had proved a stalemate, but it could have been turned to the Prince's advantage had not Murray decided to occupy Falkirk rather than follow-up the pursuit of the defeated army. The siege at Stirling was resumed without success and the Highland army eventually broke-off the operation and on 1 February retreated towards Perth

and Inverness, a day after Cumberland and most of the Royal army arrived at Linlithgow. Seven days later the Duke entered Perth and on the 21st the Jacobites occupied Inverness. From there they made a number of forays against the Great Glen posts, Fort Augustus falling after one week although Fort William proved harder to capture. Meanwhile Cumberland arrived in Aberdeen where he intended to spend the winter reorganizing his force and improving morale. The date was 27 February and Culloden was less than two months away.

THE OPPOSING COMMANDERS

Charles Edward Stuart, the 'Young Pretender'

Charles Edward Stuart was just 25 years old when he led the Jacobite cause at Culloden, having been born on Old Year's Night, 1720, in the Italian city of Bologna. His mother, the Princess Maria Clementina Sobieska, daughter of Prince James Sobieski, was an ancestor of the great John Sobieski, the saviour of Vienna from the Turks in September 1683. She had married the 31-year-old Prince James Francis Stuart, son of King James II, by proxy in May 1719, James still being in Spain in connection with the expedition to Scotland which had come to grief in the Pass of Glenshiel. Forlorn, he returned to his exile in Italy in September 1719 to find solace with his new bride. The birth of their son provided Jacobites everywhere with a cause for celebration – their hopes rested on the newborn as the one who would reclaim the throne of England.

From the beginning the child grew up in a world of intrigue and he was the intended victim of several kidnap plots. He was taught the skills of a soldier and at the ripe age of six could fire a gun and shoot a cross-bow with the accuracy expected of a much older boy; later he interested himself in the building of miniature fortifications. But apart from military matters and music, he showed flair for little else.

In 1734 the young teenager and his tutor, Murray, were invited by the Duke of Liria, son of the Duke of Berwick, to visit the Spanish forces under the King of Naples at the siege of Gaeta. Although it was intended that he be kept incognito and out of harm's way, he managed to visit the trenches at a time when the Spanish generals had retired during an artillery bombardment from the city, and officers and men alike praised his fearlessness. Yet in maturity the young Charles would show little evidence of military skill, unlike

his father who had charged repeatedly with the *Maison du Roi* against Marlborough's lines at Malplaquet in 1708, and had witnessed the failed rebellion in 1715 and managed to escape in disguise.

The death of his mother in 1735 had a profound effect on the ambitious young man and the frustrations of his life in foreign exile made him yearn for action. Four years later his chance almost came when England declared war on Spain over the latter's interference in commerce and maritime issues. There was talk of an expedition to Scotland under the Earl Mareschal who had been appointed Commander-in-Chief in Scotland by James, but the Spanish were unwilling to lend their support. Charles then hoped to see action in France but this came to nothing and he had to bide his time in Rome, where he received word of the English victory under George II and his future opponent, Cumberland, at Dettingen in June 1743.

His patience was to be rewarded within two years. Military life and adventure had always held a keen appeal for Charles and he felt confident in his skill despite years of inaction in Italy where he had become increasingly despondent. Lacking intellect and wit, this handsome young man drew his inspiration from romance and adventure, and had an enormous charisma for his adoring followers.

Although he had been blooded at Gaeta, that experience paled to insignificance when compared to the events awaiting him at Prestonpans, Falkirk, and Culloden. As these battles would prove, Charles was not an opportunist. He preferred to hand the generalship to inferior subordinates such as John William O'Sullivan rather than to the more go-ahead Lord George Murray. These two contrasting figures cast a dominant shadow over Charles and against them he was unable to assert

his authority. He demonstrated real strategic flair in conceiving and carrying out the rising in 1745, and 'thought of making war in terms of the chase: rapidity of movement, lightning thrusts, economy, sudden death.' But he lacked initiative for the grand tactic, the seeing of the whole event in the shape of things, unlike Montrose in the 1640s. For instance, after Falkirk he failed to order an advance against the demoralized English troops, or establish a defensive position at Falkirk to await

Cumberland, choosing instead to renew siege operations against Stirling Castle, which were unsuccessful and led to eventual retreat to Perth and Inverness. The retreat was a blunder and it gave the English valuable time in which to reorganize their forces. At Culloden he failed to grasp the overall situation developing before him and his delay in ordering a charge cost him many lives.

In contrast to Cumberland, Charles showed

compassion, particularly at Prestonpans where he halted the Highland slaughter before it got out of hand and remained on the field providing assistance to the wounded of both armies. In Edinburgh, following the victory, he was opposed to a blockade against the castle, preferring instead to leave guards in place to 'keep in spies and keep out fresh butter and eggs'. He was well liked and had a dynamic magnetism that endeared him to his followers.

William Augustus, Duke of Cumberland

On 15 April 1721 the citizens of London welcomed the news that the Prince of Wales and his wife, Caroline of Anspach, had become the proud parents of a new son, William Augustus, who would become the 'darling of the nation' in his youth, only to be despised in later life. From an early age he yearned to be a soldier perhaps even to become commander-in-chief of the British

army, a position he attained in 1749. He must have heard many war stories from his father who had charged at Oudenarde, and from his grandfather who had fought in the ranks of William III's army at Neerwinden in 1693. Were it not for the excesses of the Royal army commanded by Cumberland following the victory at Culloden, the Duke might have gone down in history as one of England's finest eighteenth-century generals despite the failures at Fontenoy in 1745. His unpopularity following the Jacobite rebellion coupled with his ungainly figure provided caricaturists and satirists with a wealth of material. On the other hand, he was a soldier's general, loved by his men with whom he identified. His soldiers were his pride and joy and he was sympathetic to their needs. In return they showed confidence in his leadership, proclaiming 'Now, Billy, for Flinders!'

From an early age William Augustus displayed signs of leadership, as evidenced by the commands he would give to a miniature battalion of lads in the courtyard of St. James's, but he received no formal training in the elements of military science, although he mastered the art of hunting. He was created Duke of Cumberland in July 1726, but was always overshadowed by his brother Frederick, whom he despised. William's love of soldiering eventually got the upper hand and on his nineteenth birthday in April 1740 he was appointed to the command of the Coldstream Guards, joining the regiment in camp at Hounslow. This was short-lived as he quit the camp and signed up as a volunteer aboard Sir John Norris's flagship, *Victory*, in which he served though without seeing any action. Subsequently he returned to his regiment, transferring to the First Guards in 1742. The following year found him in Germany with his father, the king, approaching the village of Dettingen with the allied army. James Wolfe, the future conqueror of Quebec, himself a young officer, said of the 22-two-year-old prince who fought the battle on the left of the first line of infantry: '[He] behaved as bravely as a man could do. He had a musket-ball through the calf of his leg. . . He gave his orders with a great deal of calmness, and seemed quite unconcerned.' Apparently William told the surgeon who was about to dress the wound

to tend to a nearby French officer whose wound was more serious. Unfortunately such benevolence was lost on the wounded clansmen who lay on the field at Culloden three years later. For his part in the victory at Dettingen, he was promoted to lieutenant-general and the following year saw him a captain-general of the British land forces at home. In that capacity he next tasted battle at Fontenoy where he was in sole command of the British contingent of the allied force against the French and he insisted on charging with his infantry. Wrote one who was there: 'He was the whole day in the thickest of the fire. When he saw the ranks breaking, he rode up and encouraged the soldiers in the most moving and expressive terms; called them countrymen.' Despite losing the battle Cumberland enabled his men to withdraw in order, for which he received much credit. Fontenoy and the British defeat was all the inspiration Charles Stuart needed for his endeavour in Scotland.

Fate brought the two Royal princes to Culloden, but Cumberland has been given the credit for making the battle possible; and for restoring confidence to the army, demoralized after its defeats at Prestonpans and Falkirk. The soldiers regained their self-respect and confidence thanks to the Duke's ability in morale boosting. This strict disciplinarian, who never shrank from using the lash, achieved something his predecessors had failed to achieve; he got his men to believe in themselves and in their ability to defeat the dreaded Highlanders. That the British Army was successful later in the Seven Years War owes something to Cumberland's reforms and training of the army and his love of its men. In the years following the battle, as commander-in-chief until his resignation in 1757, he continued to enjoy the respect of every soldier, from his generals to the lowliest man in the ranks, and even of his enemies such as Marshal Saxe. Indeed, Charles Stuart himself never shared his countrymen's hate for Cumberland, believing that a Royal prince could never have been truly responsible for the crimes committed after the battle, and he was afterwards opposed to any assassination plots against William Augustus. Yet the Duke's name lives on only as 'Butcher' Cumberland.

THE OPPOSING ARMIES

The army of the British Government, and of its sovereign lord, King George II, which stood on the wet moor of Drummoissie on the morning of 16 April 1746, can be considered a veteran force composed of experienced soldiers fresh from the campaigns on the Continent collectively known as the War of the Austrian Succession. Starting with Dettingen in 1743 and the events that culminated in the defeat at Fontenoy in May 1745, many of the regiments that fought with the Duke at Culloden were veterans of several actions. Any new recruits who had the misfortune to join up for the 'King's shilling' in the following months were soon bloodied in the débâcle at Prestonpans and the disaster at Falkirk.

The Royal Army: Infantry

Throughout the eighteenth and much of the nineteenth century, the British army exhibited the extremes of British society, the officers drawn from the upper classes and the aristocracy, while the men in the ranks came from the lowest levels of society, often poor agricultural workers or urban unemployed in search of escape from poverty and starvation. The army drew most of its recruits from the ranks of the unemployed but regiments throughout the century were rarely at full strength and had to resort to 'beating up' for volunteers; a

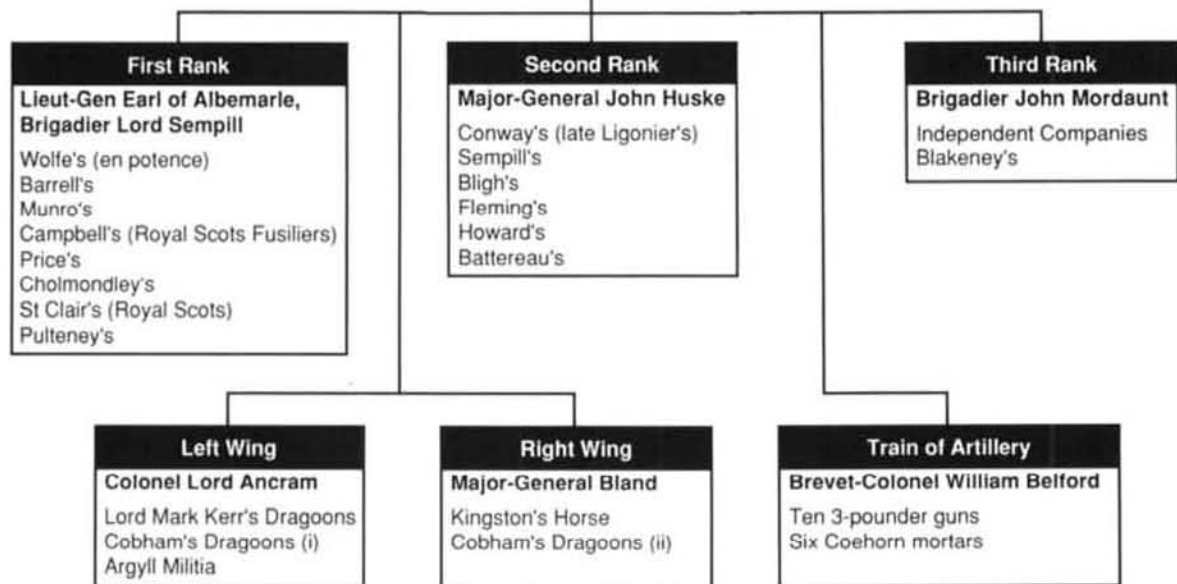

subaltern, an NCO or two and a drummer were sent to recruit, their successes coming particularly during winter and after harvest time when large numbers of men had been laid-off. When the man 'signed up' he had to swear an oath that he was a Protestant, had 'no rupture' was not 'troubled with fits', and had to have perfect use of his limbs. He had also to be 5 feet 6 inches in height. Once in the army, the new recruit was allocated to a regiment, and this became his home for life unless he was invalided out, deserted or was killed. Other troops were 'drafted'; that is, men from old, established regiments were drawn together to form new battalions, as happened in Flanders in 1743.

In 1745, however, with the Jacobite emergency in the north, other inducements to join the army were quickly introduced to fill the ranks of the depleted home-based regiments. On 6 September,

every recruit who joined the Guards before the 24th of the month was offered a bounty of £6, and those joining in the last six days of September were offered £4. Elsewhere various noblemen offered to raise and equip two regiments of horse and thirteen regiments of foot, and a group of volunteer horseman was organized in Yorkshire.

According to the *Army List* of 1745, there were 56 regiments of Foot, three regiments of Foot Guards and two regiments of Grenadier Guards, 14 regiments of Dragoons, and eight regiments of Cavalry. However, new regiments were raised during 1745 and 1746, increasing the number of infantry regiments to 80. The same publication lists the total number of troops in Great Britain in 1745 as 18,507.

Regiments were identified by the name of their colonels; thus, the 1st of Foot was St. Clair's; the

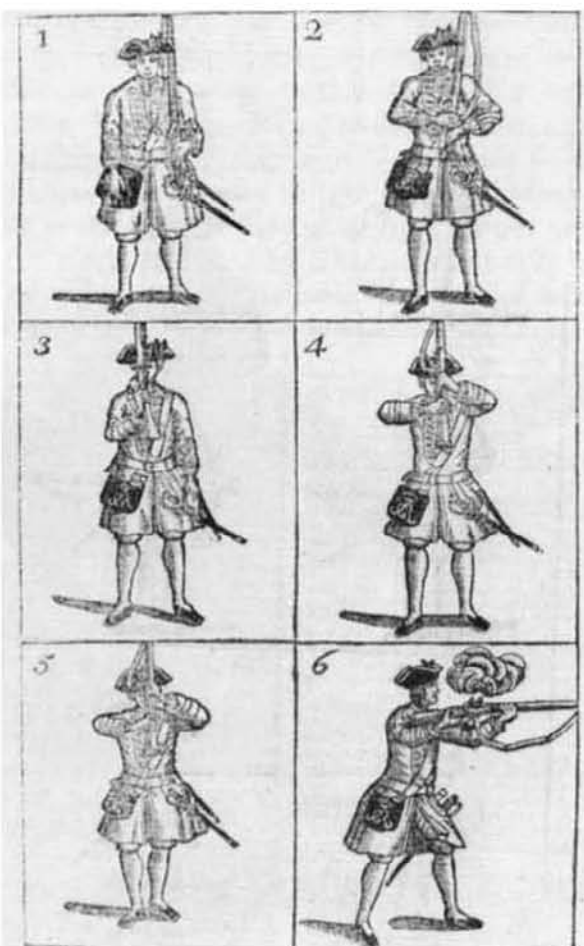
13th, Pulteney's, and so on. Each regiment consisted of ten companies of 70 men. With officers, the regiment was set at 815 men, but rarely did the units maintain those numbers and many of the regiments at Culloden were little stronger than about 400 men. In a dragoon regiment, there were six troops of 59 men, making a total of 435 men and officers. The forces serving in Flanders in 1745 had twelve companies of 70 men each per regiment, while the cavalry had six troops with more men, 75, in each. The total number of troops serving in Flanders at that time was estimated at 28,026 officers and men. Other British contingents were serving in Ireland, Minorca, Gibraltar, the American colonies, and the Caribbean. At Culloden it is estimated that Cumberland commanded 6,400 infantry and 2,400 cavalry.

Once the new recruit arrived at the barracks or garrison, he was presented with a 'good, Full Bodied Coth Coat well Lin'd' of red serge faced with the colour of his regiment, a waistcoat, kersey breeches, strong stockings and shoes, shirts, neckcloth and a 'Strong Hat well Lac'd. Caps to Fusiliers,' but these would have to last. From then on his living conditions were miserable, and if he did not toe the line he would be disciplined with the cat-o'-nine tails. His food was abysmal and he was expected to pay for it. Other deductions from his meagre pay went towards the regimental surgeon, the regimental agent, and towards the upkeep of Chelsea Hospital. The Scottish emergency brought some relief to the common soldiers in terms of a new flannel waistcoat presented to each man by the Quakers, and in London a subscription was started in order to provide a blanket and two paillasses for each tent, a pair of worsted gloves to each man, and thirty watchcoats for each battalion.

Fortunately for the soldiers who fought at Culloden, few had lingered for long periods in filthy barracks and their discipline had been honed by their endeavours on the Continent. Armed with a firelock, the British battalions in the Allied line at Dettingen gave a 'regular, swift and continuous fire' in volleys that devastated the French. At Fontenoy, the British troops had been badly hit by French artillery and cavalry, a fact no doubt noted by Cumberland. However, the failure at Fontenoy

had a psychological effect on the soldiers that may have contributed to the setbacks in Scotland. When Cumberland again resumed control of the army at Aberdeen early in 1746, he set about instilling confidence in the troops and initiated a series of new tactics for the infantry. In the three months between Falkirk and Culloden, the soldiers were put through intensive drilling, particularly a new method of bayonet drill, to restore confidence.

Aside from the new bayonet tactic (to lunge at the opponent to one's immediate right) the army at Culloden followed the tactics laid down in the 1728 Regulations, and to a lesser extent the numerous minor manual and platoon exercises and engraved plates of such. For instance, in 1745 a series of plates appeared showing the several 'positions of a Soldier under arms'. The chief weapon of the British army at this time as depicted in these exercises was the scaled pattern Long Land musket introduced around 1745, also known as the 'Brown Bess'. It had a 46-inch barrel with a long fore end and a wooden ramrod. With a bore of .75in, its bullets were 13 or 14 to the pound. It used flint and steel to generate a spark igniting the charge of gunpowder in the pan; this was connected by a small channel to the musket barrel wherein lay the main charge. The cartridge was made up of a tube of strong cartridge paper sealed with thread at both ends. It enclosed six to eight drams of powder and a lead bullet. After biting off the rear end of the cartridge, the soldier squeezed a small amount of powder into the pan and emptied the rest into the barrel. The bullet was next inserted and rammed down with the paper cartridge serving as wadding (although banging the butt of the musket on the ground served the same purpose and also sent powder into the pan, thus eliminating the necessity of placing the powder by hand into the pan). A trained soldier could fire four to five rounds a minute, but the musket was generally inaccurate over fifty yards owing to the looseness of the bullet in the bore, and there were also frequent misfires as a result of the failure of the powder to penetrate into the pan. The soldiers in the Royal army were issued twenty-four rounds. Along with a socket bayonet with a triangular-section blade of seventeen inches in length, the

infantryman carried a hanger with a polished brass hilt and a blade some 27 inches long. This was carried in a black leather scabbard fastened to a 2-inch wide belt.

The Royal Army: Cavalry

The cavalry had arrived in Scotland in the middle of January 1746, having spent the last few years on garrison duty or policing the southern English



coast for smugglers. Some had been bloodied earlier on a snowy December night above the moors of Westmorland at Clifton, near Penrith, when four dismounted troops of English cavalry attacked a small force of retreating Highlanders. The affair was over in a few minutes with no clear winner. As a consequence, the cavalry at Culloden were hardly combat-experienced.

Made up of volunteers, who were not to exceed 5 feet 8 inches in height, most had barely

progressed beyond basic training. This consisted of the care of the horse, cleaning stables and undergoing the same basic training of a foot soldier. The horses were not to be older than four years nor over 15 hands high. Occasionally small and lighter horses were bought 'keeping however, still to the black Cullour'. Once the trooper had been taught to control his horse, he was taught to ride and then to perform mounted evolutions such as opening and closing rank and wheeling in line.

The next stage for a dragoon recruit was to learn to fire his carbine and pistols from the saddle.

Emphasis was laid upon swordsmanship, and new tactics were periodically introduced. On 10 March 1746, the following order was given to the dragoons in Scotland: 'H.R.H. orders that all Officers of Dragoons who may happen to be at the head of a squadron, party or detachment of Dragoons, when there may be likelihood of engaging the enemy, are to make their men sling their firelocks just before they draw their sword, and to take particular care to hinder their men from handling their pistols, unless when in pursuit

of a broken enemy, running from them.'

The standard cavalry firearms were the Land Service pistol and the carbine. The pistol had a 12-inch barrel of 17 or carbine bore and a heavy butt. With the standard flint carbine lock, the overall length was between 18 and 20 inches. The other dragoon firearm was the carbine, with a barrel length of between 27 and 36 inches, a 17 bore and twenty bullets to the pound. The Duke of Kingston's Light Horse, which was raised for the Jacobite Rebellion and then disbanded later in 1746, had a shorter carbine. The trooper's other weapon was his sword which had a heavy brass

bowl guard, a brass ball pommel and a straight 35-inch long blade, which was carried in a black leather scabbard.

The Royal Army: Artillery

At Culloden, it was the artillery which was to prove the most devastating weapon against the ranks of the Jacobite infantry. The ten 3-pounder guns under William Belford drawn up in pairs at intervals between the six front regiments, and the six Coehorn mortars, in two batteries of three, were extremely effective against lines of stationary troops: 'The guns were so exceedingly well plied that they made dreadful lanes through some of the clan regiments', wrote one observer.

However, the success of the artillery in the battle can be attributed to the lessons learnt earlier in the rebellion. Prior to the battle the state of the artillery had been described as deplorable. It had performed poorly at Prestonpans, but allowance must be made for the absence of trained gunners – the guns were in fact served by seamen. Some success was achieved by six 18-pounders upon the crumbling walls of Carlisle in late December 1745, which forced the city to surrender. At Falkirk the artillery, a strange assortment of ten cannon, fared little better under Captain Archibald Cuninghame; the civilian drivers of most of the guns fled the field, and many of the guns became stuck in a bog. Of the pieces that had been with Hawley's army, seven were captured. One obvious need was greater mobility for the artillery, and this was addressed in the weeks following Falkirk.

In 1743 the Royal Regiment of Artillery consisted of eight companies, only one of which was present at Culloden, the others being at Woolwich, on the Continent or in North America. A company consisted of approximately seven officers (captain and lieutenants), three sergeants and three corporals, eight bombardiers, 20 gunners, 62 matrosses, and 2 drummers, a total of 105 officers and men. The principal weapon at this time was the 3-pounder smooth-bore muzzle-loader on its distinctive and clumsy double-bracket carriage. The range of fire was about 500 yards and it fired two kinds of missile: round iron shot and canister, which was filled with metal frag-

ments. The Coehorn mortars had a calibre of $4\frac{2}{5}$ inches. Various smallarms were also carried by the men including halberds, brass-hilted swords and muskets.

The Allied Contingent

The Royal Army during the period of the rebellion contained elements of foreign troops. Under the terms of a previous treaty 6,000 Dutch soldiers had been ordered to England at the

beginning of the campaign and a Dutch regiment had been on board a ship in the Firth of Forth during the battle of Prestonpans but had been warned against landing. Most of the Dutch forces were garrisoned at Newcastle under Field Marshal Wade, but were rendered immobile when the Irish troops from Louis XV's army landed, having agreed not to raise arms against the French king following the Dutch surrender of Tournai a few months earlier. For the duration of the Scottish troubles five thousand Hessians under Prince Frederick were taken into British pay.

However, the main non-English troops serving with Cumberland's army were the Independent Companies, a number of volunteers and auxiliaries raised by various loyalist clan leaders, and the Argyll or Campbell Militia. At the outset of the rebellion, the Government delegated Duncan Forbes of Culloden and Archibald, 3rd Duke of Argyll to raise twenty Independent Companies of Highlanders and a Regiment of Militia loyal to the Hanoverian Succession. Initially the task of the Companies was to disrupt Jacobite recruitment and taxation, to 'live at discretion in the counties which the rebels have left'. Each company was made up of a captain, lieutenant, ensign, four sergeants, four corporals, one drummer, one piper, and one hundred private men who were to be 'regularly enlisted, subsisted, paid, armed, equipped and clothed'. The main weapon was the broadsword in addition to side-pistols, targets and dirks. The target or shield was 19 to 21 inches in diameter made of wood covered with leather and having brass studs. All the companies appear to have worn Highland dress and their only emblem of allegiance was the black cockade and red cross in the bonnet. At Culloden the Independent Companies with the exception of one detachment were held in reserve and saw little action.

Not so the Argyll Militia, a regiment in itself and quite distinct from the Independent Companies. Raised by the Duke of Argyll, it played a particularly prominent part in breaking down the walls on the left flank and providing flanking fire for Cumberland's dragoons to outflank the Jacobites. They were ably assisted in this task by the small detachment from the Independent Companies. The regiment numbered some 1,000 members of the Clan Campbell in ten companies by the end of 1745. Their recruitment, terms of service, discipline, pay and subsistence was similar to the Independent Companies. Originally the intention was to cloth all Scottish loyalists in a short red coat and long waistcoat, belted plaid, red and white hose and a round blue bonnet, but due to delays and shortages the uniform was never issued. As a consequence, each militiaman wore

his Highland dress and tartan with the Hanoverian black cockade and large coloured cross on the bonnet. Arms were issued, the main weapons being a musket, bayonet, broadsword and side-pistol which served to complement their own target and dirk. At Culloden, the regiment's strength was 630 officers and other ranks but the unit was disbanded in August 1746 although some men joined the new independent companies and other new corps such as Loudon's Highlanders and the Black Watch.

The Jacobite Army

The army that gathered around Prince Charles Edward Stuart in 1745 to achieve the restoration of King James VIII did not exist prior to 19 August 1745 when, at Glenfinnan, Charles, acting as Regent, raised the Stuart Royal Standard. Over

the next few weeks the main elements of what was to become the Jacobite army came together, and at its peak at Falkirk reached a maximum strength of 8,000 men. Even this however was a small fraction of the fighting potential of the Highlands, estimated at more than 32,000 men. On the orders of the clan leaders, hundreds of clansmen from the Camerons, Macphersons, Appin Stewarts, Keppoch, Glengarry and the Macdonalds of Clanranald, came forth. They were joined by feudal levies such as the Atholl brigade, made up of men who served their lords under the terms of their land tenure. Others were volunteers, one example being the Manchester Regiment. While numbers varied from regiment to regiment, for the most part they were each approximately 500 men strong. Two of the largest clan regiments were Lochiel's Camerons and the Macdonalds of Glengarry. Clans such as the Campbells, Grants, Munros and

Sutherlands were Whigs in political sympathy and did not join the Prince, while others joined the Hanoverian government or abstained from intervention. Some regiments like Ogilvy's had two battalions with about 300 men in each although at Culloden the combined battalions totalled only some 500. The muster-roll of this regiment mentions 73 officers, 20 sergeants, 5 drummers and 528 privates. Of the officers, one was the colonel (Lord Ogilvy), two were lieutenant-colonels, a colonel serving as aide-de-camp, two

majors, an adjutant, a paymaster, 21 captains and the same number of lieutenants, nineteen ensigns, two chaplains and two surgeons. These officers, all kilted (like the privates) in the Ogilvy tartan, were farmers or merchants, the men being labourers, craftsmen, domestic servants and land-holders. One fundamental problem for the Jacobite army was the lack of officers, and Charles's choice of Irish and French officers, which caused much disagreement among Scots.

The lack of professionalism and training of the

Jacobite infantry was frequently apparent. The Keppoch and Glengarry Macdonalds lacked proper discipline and were considered uncontrollable by their colonels. In one incident, Keppoch's men, having shot the Marquis of Lothian's fallow deer, turned their guns on their officers who had shouted to them to stop, but no casualties were reported. In 1745 a Government agent in Durham reported that the clansmen were totally out of hand and that their officers, fearing a revolt, indulged them.

Unlike the government army, discipline among the Jacobites was not imposed by the lash; morale was maintained and personal loyalty instilled by their leaders. Although desertion was rare during the invasion into England, the 1746 campaign in Scotland saw some clansmen leaving the army for more pressing matters. Deserters arrested were not executed but rather persuaded to rejoin. As for looting and rapine, there were no reports of such activities during the invasion into England owing to the regular method of financing the army by

collecting public funds, such as sequestered estates and taxes.

Unlike their opponents, the Jacobite army had an array of weapons at its disposal. The clansmen wielded basket-hilted broadswords, dirks, muskets and pistols. Of the traditional clan weapons, the Lochaber axe was rarely used during the campaign, but the target or shield was carried by both Highlanders and Lowlanders. A few bayonets

were also in evidence. Firearms came from France and Spain but were in short supply as was ammunition, which meant that the soldiers entering England in 1745 were issued 'twelve shot' – twelve lead balls, powder and paper for securing the charge – with restrictions on wastage. This was considered meagre by contemporary standards, leading some to suggest that the Jacobite army could not fight a pitched battle.

One surviving account describes the method of a Highland attack at the time: '[The Highlander] when descending to battle, was to place his bonnet on his head with an emphatic "scrug"; his second, to cast off or throw back his plaid; his third to incline his body horizontally forward, cover it with his target, rush to within 50 paces of the enemy's line, discharge and drop his fusée or musket; his fourth to dart within 12 paces, discharge and fling his claw-butted steel stocked pistols at the foe-man's head; his fifth to draw claymore and dirk at him!' Another account states that the Highlanders 'stooped below the charged bayonets, they tossed them upward by the target, dirking the front rank man with the left hand, while stabbing or hewing down the rear rank man with the right; thus, as usual in all Highland onsets, the whole body of soldiers was broken, trod underfoot, and dispersed in a moment'. (All this while charging barefoot and refusing to wear shoes even on the march.)

As for the Prince's artillery, which performed poorly at Culloden, he had to hand thirteen pieces of cannon of varying calibre, the largest being a 4-pounder. The different calibres must have created ammunition supply problems. Six were Swedish guns ranging in size from 2- to 4-pounders. The remaining weapons, six 1-pounder Coehorns, came from the Tower of London, having been captured at Prestonpans. This odd assortment of cannon were manned by inexperienced gunners, and at Culloden some of the weapons on the left-wing were manned by volunteers who succeeded in firing only two rounds; the guns in the centre did succeed in killing five or six redcoats.

In terms of cavalry, the Prince could count on five troops of horse, but each varied in strength from month to month. Elcho's Life Guards, around 160 in all, consisted of seventy men and their servants under five officers in October 1745, but at Culloden less than half were present. In their special uniform of blue trimmed with red, they were regarded as a key corps. In contrast, Lord Balmerino's Horse numbered only 40 troopers who, like Elcho's, fought dismounted at Culloden; 16 troopers were also with the Prince in reserve. The horse grenadiers were commanded by the 37-year old Earl of Kilmarnock, but they also included the Perthshire Horse, 130 men

organized into two troops under Lord Strathallan. At Culloden, the Perthshire Horse were stationed to the left of Lord Pitsligo's Horse, made up chiefly of gentlemen from Aberdeenshire and Banffshire and totalling about 160 under the command of the 60-year old lord. The final Scottish cavalry contingent were hussars under the command of an Irish officer, Colonel Baggot. (John Murray of Broughton, the Prince's secretary, had been the original commander of this force, but missed the battle due to illness.) The hussars were considered poorly trained and were regarded as the weakest arm of the cavalry. Like the Life Guards, Pitsligo's men were considered the finest of the Jacobite cavalry, although at Culloden most of the Jacobite cavalry were forced to fight on foot and could not demonstrate their riding prowess.

As for pay, according to Lord Elcho a captain was paid 2s 6d per day, a lieutenant 2s, an ensign 1s 6d and a private 6d, although Lord Balmerino states that the 'gentlemen' received 2s per day. At the trials following the end of the rebellion, it was mentioned that privates in the Jacobite army received a daily allowance of 7d or 8d. For the cavalry slightly more was paid, sergeants receiving 1s 8d and rankers 1s. While on paper these were the expected amounts, as the campaign wore on and money became scarce, payments fell into arrears, the men receiving meals in lieu.

The Irish and French Contingents

At Culloden the Prince was served on the left flank by a Franco-Irish cavalry regiment, Fitz-James's Horse, which had landed in Scotland in late 1745 from Ostend. Under its commander, Colonel Robert O'Shea, it numbered only 70 at the battle, many of the troopers having surrendered on the march northwards out of England. They were further handicapped by their horses having been captured at sea. Nevertheless, they were the only cavalry regiment on the Jacobite side at Culloden to fight the whole battle on horseback. The regiment was clothed in red coats turned up with blue, yellow skin breeches, black tricorne hats laced with silver, and beneath their coats black-painted iron breastplates. Their weapons were carbines or muskets, pistols and straight brass-hilted swords.

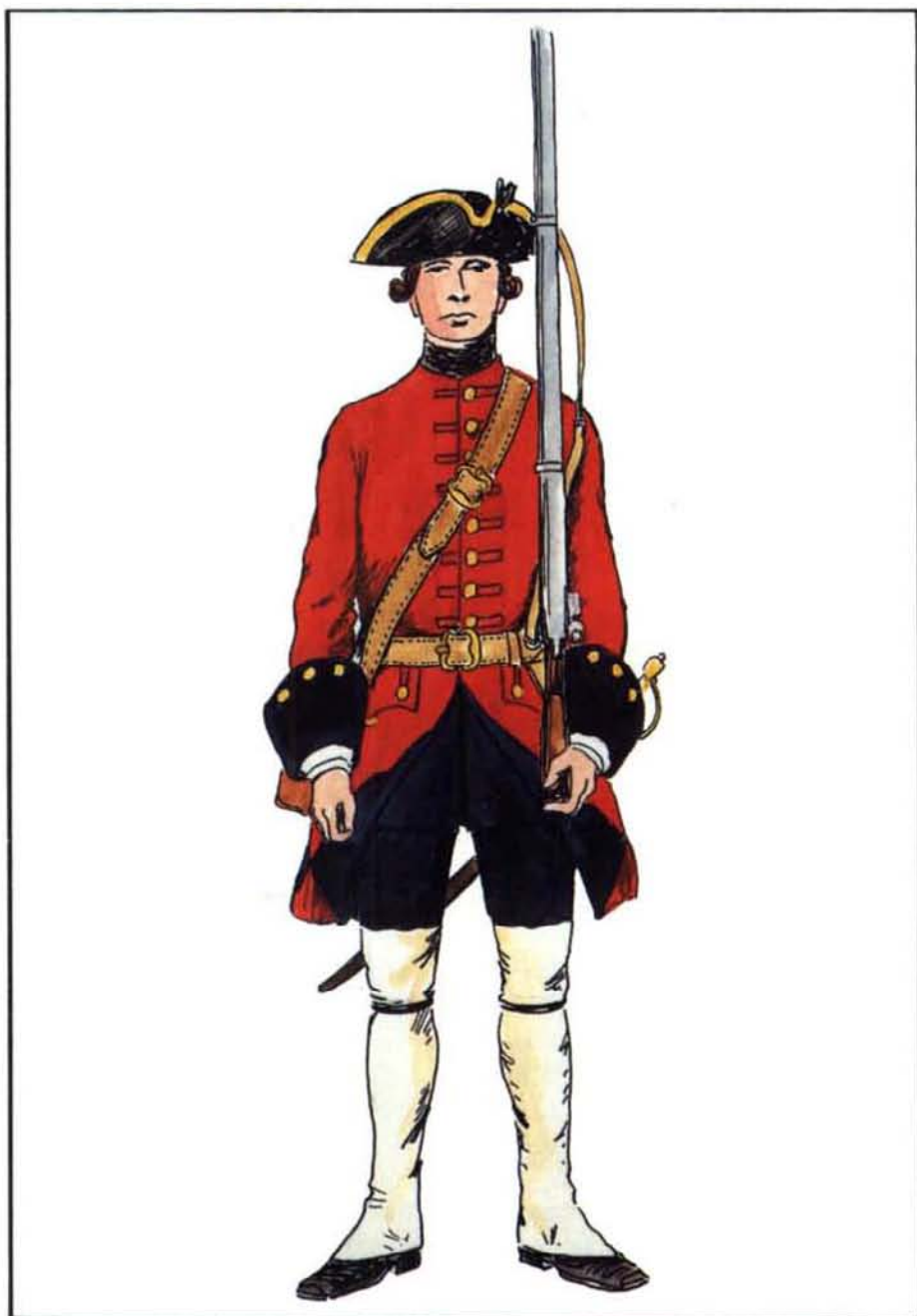

Of the original four squadrons, only one had landed at Aberdeen, numbering about 120-130 men, the other three along with picquets of five Irish regiments of foot still being aboard transports. Unfortunately for the Prince, two of these transports were captured by Commodore Knowles on February 24. This was a bitter loss, for the regiment had considerable experience in battle,

having seen recent service in Italy and on the Rhine with the French army.

While the majority of the Irish picquets and Fitz-James's Horse were captured, about 359 men and 36 officers in all, a number of men from various regiments of the Irish brigade did see action in the campaign. About 750 soldiers from the Irish regiments commanded by Brigadier

Stapleton and Lord John Drummond's French Royal Scots had landed on the east coast at the end of 1745. The picquets were mainly Irishmen drawn from the six Irish infantry regiments in French service, and they along with their officers had distinguished themselves earlier in the year at Fontenoy against the same enemy. According to one eyewitness of the Irish troops who were

captured at sea, 'the men are all clothed in red, and their officers have mostly gold-laced hats. To speak impartially the officers are as proper men as ever I saw in my life, being mostly 5 feet 10 or 6 feet high and between 40 and 50 years of age; and the common soldiers are very good-like men, and if they had landed might have done a great deal of mischief.'

CULLODEN: THE APPROACH MARCH

On 30 January 1746, with the unfortunate Hawley, the loser at Falkirk, as his commander of cavalry, the Duke of Cumberland, Commander-in-Chief of the Royal army, arrived by ship at Leith, the port of Edinburgh. His predecessors, Cope and Hawley, having failed to remove the Jacobite threat, the Westminster government considered the Duke to be the only man left for the job, and the Duke himself was determined to bring the Jacobites to battle and defeat them once and for all. With the onset of winter, he decided to move his troops north to Aberdeen and await better weather before proceeding. During this respite, the army was increased with the addition of 5,000 Hessian mercenaries under Prince Frederick of Hesse, who took up a position to the south to block any retreat by the Pretender's forces. More importantly, the Duke used the time to drill his troops in new infantry tactics. The bitter experiences at Prestonpans and Falkirk had shown that the bayonet was no match for a frontal attack by a Highlander armed with a target which could parry the bayonet. However, some shrewd thinker observed that the attacking Highlander was unprotected on his left side; therefore, if each soldier engaged the enemy immediately to his right rather than directly to his front, he would be covering his neighbour, and the Highlander, carrying his target in his right hand, could be caught. The extreme left-hand file presumably was covered by an officer or sergeant standing on the flank.

By 8 April the weather had improved to the extent that the roads were clear of snow and the River Spey was fordable. Supplies had been gathered and the army moved off, reaching Cullen by the 11th, where the Duke's force was joined by Albemarle with six battalions and two cavalry regiments that had been wintering at Strathbogie, and General Mordaunt's reserve force of three battalions and four guns from Old Meldrum. Three days later the army crossed the Spey,

undeterred by Lord John Drummond's 2,000 Highlanders who had been holding the riverside, but quickly withdrew leaving the path open to Nairn. On the 15th, the bivouacked army celebrated the Duke's 25th birthday with a helping of liquor for all ranks, two gallons of brandy having been issued to each regiment. By now Drummond's troops and those of the Duke of Perth had reached Culloden in a dejected state. Morale in the Royal army was high, however, and the soldiers appreciated the fact that Cumberland had marched part of the way with them on foot.

During the period that the English troops had been moving north the Jacobites, farther to the west, had been subduing the Highland posts at Ruthven, Fort William and Fort Augustus and had now returned up the Great Glen to Inverness. It had become clear to Charles that he would have to weather a general action to achieve his goal, and the call went out to rally his supporters, many of whom had returned to their homes. On 14 April, to the sound of the pipes, the Jacobite army marched eastward out of the town for five miles towards Drummoissie Moor where they camped in the woods and fields adjacent to the moor close to Culloden House. At a council of war it was decided to attempt a surprise night attack on the Royal camp, but the plan was made too hastily to succeed. Late on the following day the force moved towards Nairn, but the columns failed to keep their distance and the subsequent delay and confusion wrought havoc among troops unaccustomed to such a delicate operation. The Jacobites were discovered and forced to retreat to Culloden which they reached in the early hours of the 16th, tired and forlorn. To their consternation they found that the supplies had been left behind at Inverness, and as there was no time to retrieve them, some of the men lay down on the cold ground to sleep, while others went out to forage. Prince Charles did not return to Culloden until

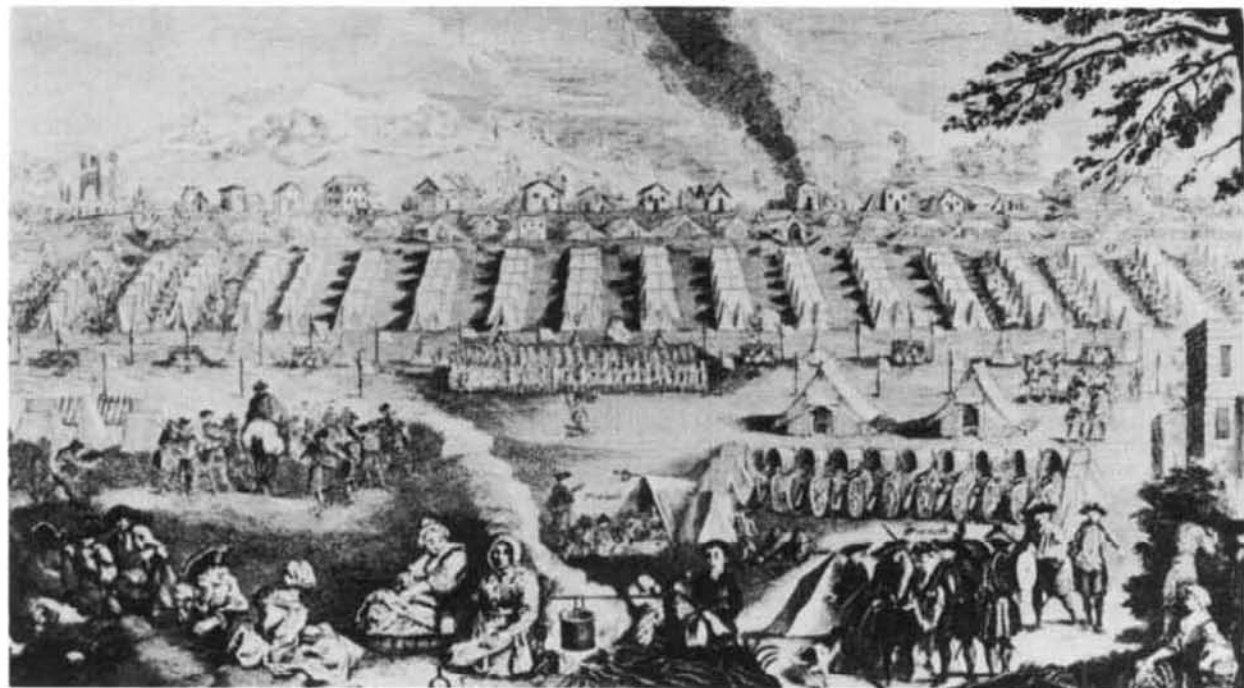

7.00 a.m., having ridden twelve miles to Inverness and back in search of food for his troops. He even threatened to burn down the town should they refuse his request, but before he had time to carry out this threat the Duke of Perth, fearing an imminent attack, persuaded him to return to Drummoissie.

There, Murray asked the Prince whether he still planned to fight a battle that day. Charles replied that there was really no alternative given the fatigued condition of his officers and men who would be in no state to conduct an orderly retreat from the Royal army. Murray suggested three

possibilities: to retire to Inverness and prepare for a siege; or the army could disperse into the Highlands and await another chance in the following spring; finally, if Charles wanted a battle the army should cross the Nairn to the more suitable position that had been reconnoitred the day before and deemed unfit for cavalry. These alternatives were dismissed despite Murray's suggestion that a battle on Drummoissie Moor could end in defeat and the loss of Inverness. Another member of the Prince's staff, the Marquis d'Eguilles, special envoy of Louis XV, also commented on the poor condition of the troops and urged the alternative

The March to Culloden, 8-15 April 1746

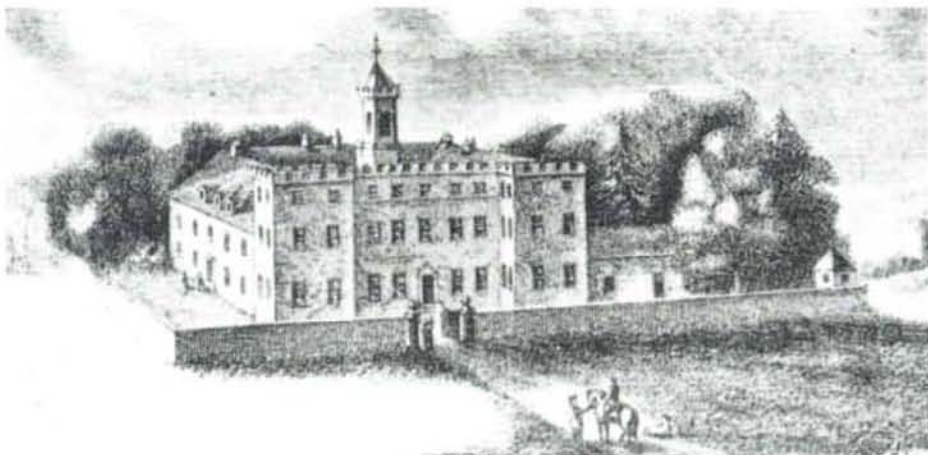

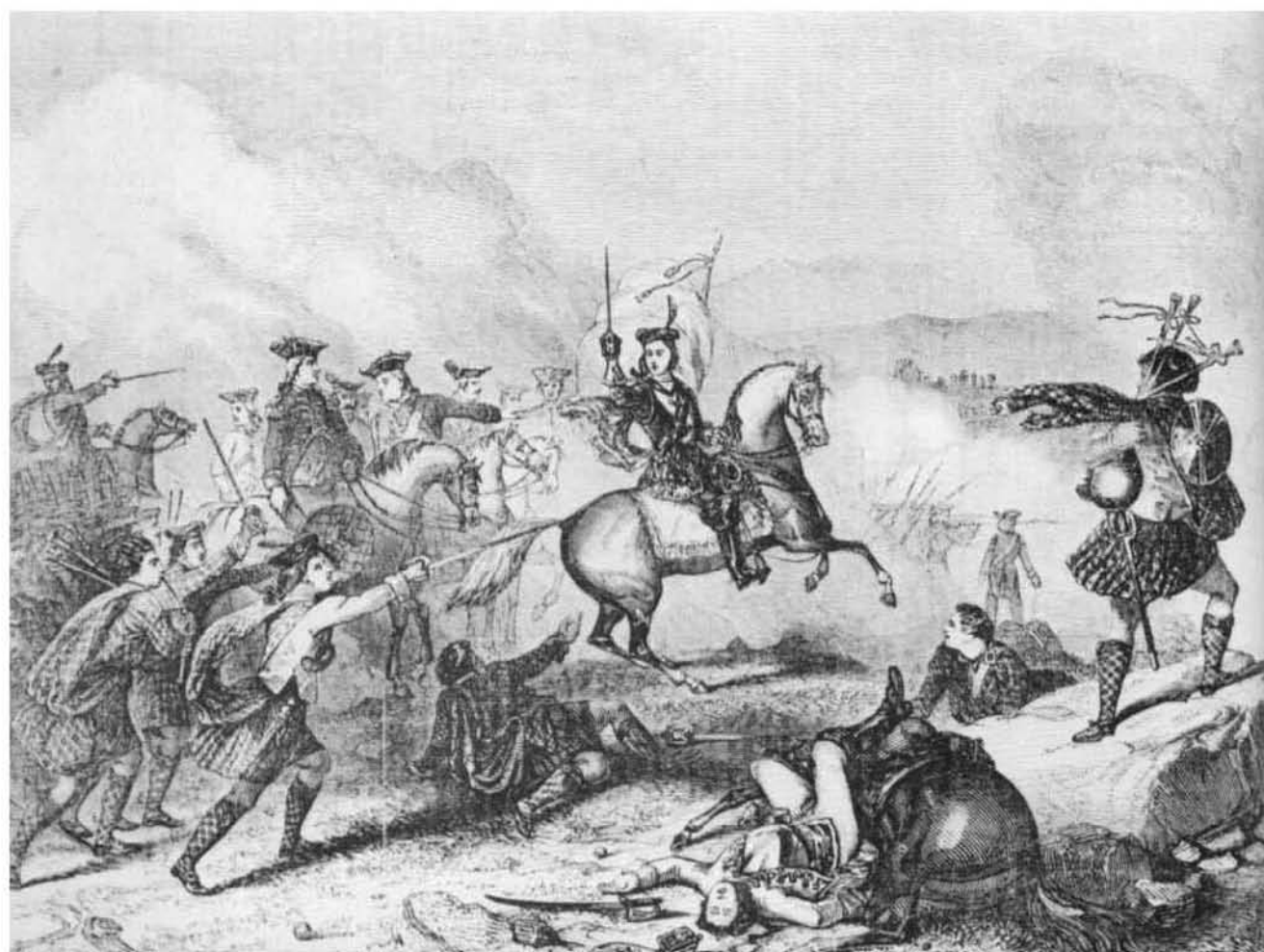

field, but to no avail, despite a plea on bended knee.

Early on that cold rainy morning of Wednesday the 16th, the Royalist troops struck camp, having eaten sparingly and drunk some brandy. Fresh from a good night's sleep, they were moving off

towards the moorland around Drumossie and Culloden by 5 a. m. On the moor, which was well suited to the manoeuvres of foot and cavalry, the government army had the pick of the land and deployed on firm, level ground. The battle was now inevitable.



THE BATTLE OF CULLODEN

When the Royal army was within four miles of Drummoissie its advance guard was sighted by Jacobite pickets. The Duke's informers reported that the rebel army was moving into position about a mile from Culloden House. At about eleven o'clock under heavy showers the two armies came into sight of each other across two miles of the open moorland. Cumberland ordered his columns to halt and take up their battle formations. As organized by his staff, Lieutenant-Generals Hawley and Albemarle, Major-General Bland and Brigadier Lord Sempill, three lines of troops deployed along a 700-yard front between the walls of cultivated enclosures and moved to within 500 yards of the rebel lines. In the front line running from right to left were: Pulteney's St. Clair's Royals, Cholmondeley's, Price's, Campbell's Royal Scots Fusiliers, Munro's and Barrell's. A hundred or so yards behind, forming the second line, from right to left were the regiments of Howard, Fleming, Bligh, Sempill, Ligonier and

Wolfe, all commanded by Major-General Huske. Bringing up the rear were Blakeney's and Battereau's Regiments under the command of Brigadier Mordant. On the flanks, the cavalry were arrayed with Viscount Cobham's and Lord Mark Kerr's dragoons, directed by Colonel Lord Ancram, on the left with elements of the Argyll Militia. They took up position just within the Leanach enclosure and out of sight of the main Jacobite force. Kingston's Horse took up their position on the right flank under Bland. The deployment of the army pleased Cumberland and he made a short speech in which he implored his soldiers to defend King, country, religion, liberties and properties. The Royal lines then moved forward with fixed bayonets and came to a halt. Seeing this, one French officer told the Prince that he feared the outcome of the battle already determined for he had never seen men advance in so cool and regular manner. A similarly despondent Murray asked by Elcho about the day's prospects replied, 'We are putting an end to a bad affair.'

By one o'clock the opposing armies had taken up their respective positions and were at the ready. Charles had barely 5,000 men in all but expected the arrival of 2,000 absentees at any time. The Jacobite lines, facing east across the moor, were hopelessly askew prior to the battle, varying in distance from the English lines anything from between three and five hundred yards. They were also hemmed in between park walls on each flank, and as the wall on the left ended well before the wall on the right, the slanting was even greater. Lord George Murray had requested time to view the ground, but the impatient Prince had overruled him. Both men had failed to notice that the ground between their army and Cumberland's was considerably boggy and would make bad going for charging men. Murray's request to break down the western walls of the Culloden enclosures so as to

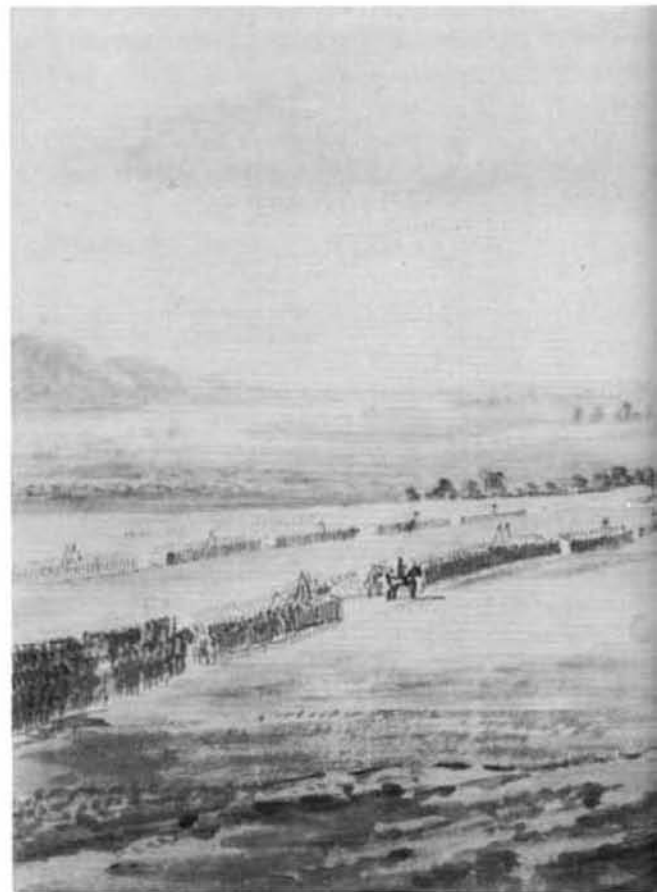

allow the Athollmen to charge unimpeded was similarly rejected. The order of battle was arranged by Murray's bugbear, the Irishman O'Sullivan, who caused some dissent by refusing to allow the Camerons their traditional place at the right of the line. The choice of ground – a level, open stretch of moorland ideally suited for the movement of cavalry – was also O'Sullivan's.

From left to right the front line of the Jacobite army, stretched for 700 yards between two enclosure walls although many clansmen were still arriving on the field. The centre of the front line was commanded by Lord John Drummond, with the Duke of Perth commanding the left and Lord George Murray the right. The second line of the Prince's force was some seventy yards behind. Bringing up the rear were the few mounted troops of the Jacobite army. In all, the army was about 5,000 strong, but to many a trained eye it was obvious that the Jacobite army was in a hopeless situation as it faced the ordered lines of Royalist



soldiers across the moor.

Some Highland officers feared a flanking movement on their right and left and suggested lining the walls with men, but their fears were quashed by the optimistic O'Sullivan. Charles shared his optimism, particularly when he observed that some of the Royal troops were having trouble deploying around the marshy ground on the right and left. For a few minutes the right wing of Cumberland's army was exposed as it attempted to negotiate the boggy ground and seeing this opportunity the Prince sent a message to Murray to move against the enemy, but for some unknown reason the Scottish lord did not comply. Possibly Murray felt that he had insufficient troops to make the attack; many Jacobites were only now arriving on the field. More probably Murray wanted Cumberland's front line to advance to the Leanach enclosures before he attacked.

Having stood for some time with rain and wind whipping their faces, the tired and hungry High-

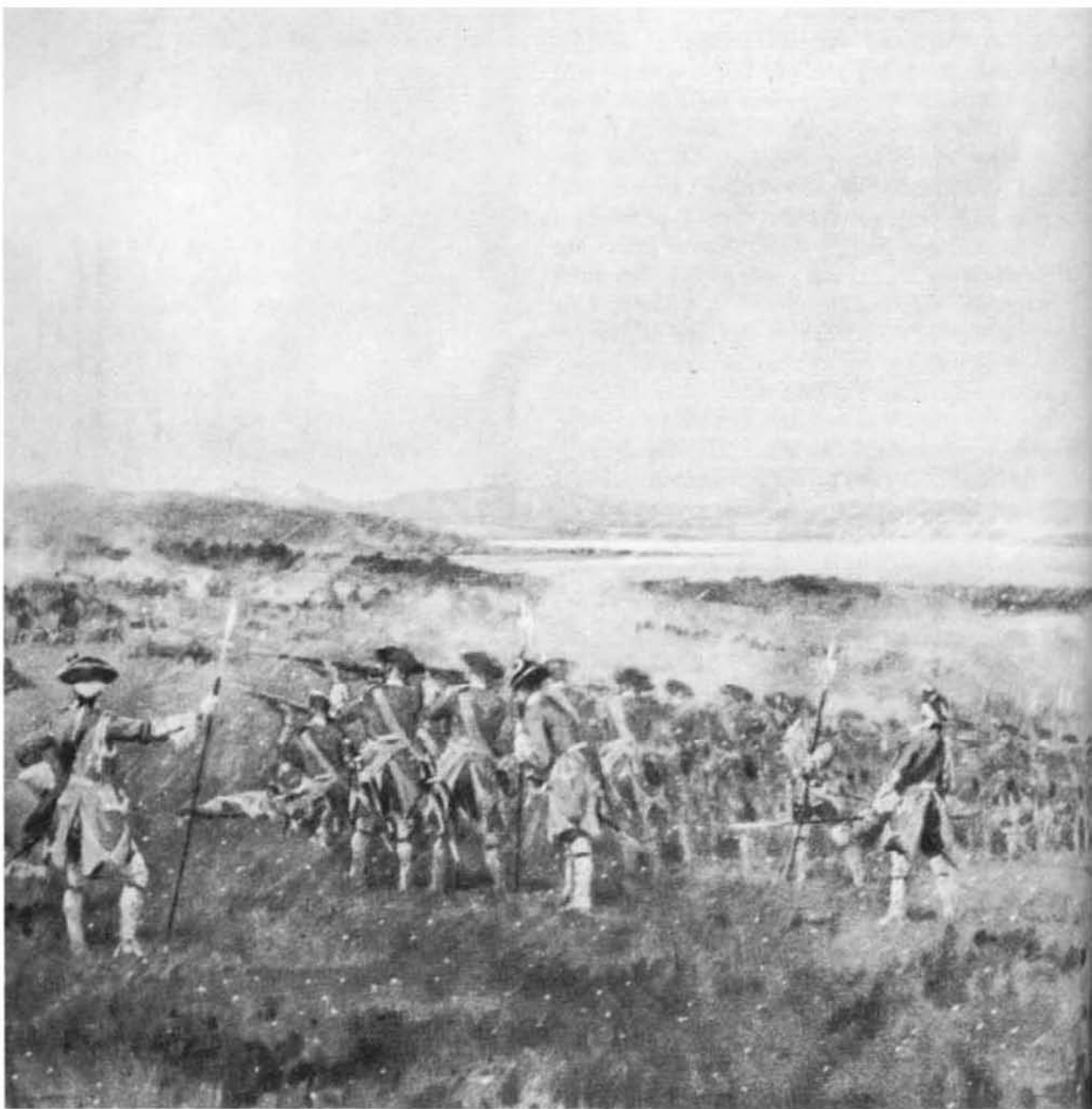
landers were in no mood to fight the 8,000 Redcoats and several hundred Argyll militia arrayed in three lines facing them across the several hundred yards of open moorland.

The Opening Cannonade

Having halted his army and retrieved the artillery which had been bogged down, the Duke called up his 3-pounders and placed them in pairs between the six front-line regiments. Six Coehorn mortars were deployed in two batteries slightly ahead of the two regiments on the wings of the second line. In comparison the Jacobite artillery strength was insignificant: twelve guns of various calibre, ranging from 1- to 4-pounders, were deployed in three 4-gun batteries in the centre and on the wings of the front line.

Much to Charles's displeasure, the Royal army showed no sign of advancing and anxiety swept through the eager Highlanders. Shortly after one





o'clock, under rain showers, someone in the Prince's army – possibly the Master of Ordnance, John Finlayson – ordered the few inexperienced gunners manning the batteries to fire on the red lines. Apparently the Prince's artillerymen were provoked by the appearance of Lord Bury, the son of Lord Albemarle, within 100 yards of the Highlanders. He had emerged from the dead ground between the two armies after an un-

successful reconnaissance of the rebel battery positions, and returned to the ranks of his cheering countrymen as the first shot from the Jacobite centre battery sailed over his head and killed a soldier in the rear. The round had been deliberately ranged on the rear ranks where the Duke was thought to be. A second shot from the battery on the left wing narrowly missed the conspicuous, 18-stone Cumberland, astride his large grey horse,

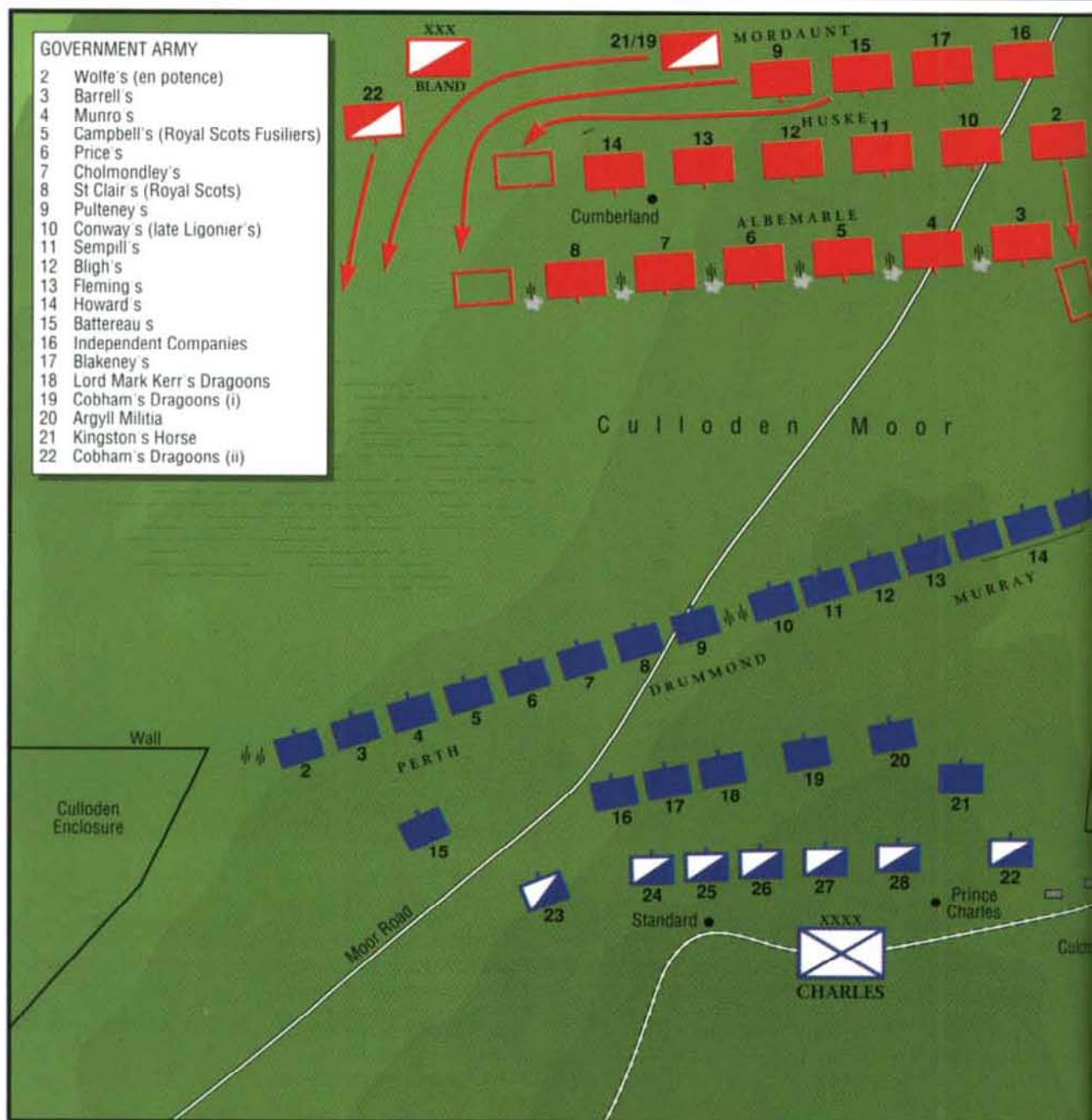

but killed two men in front of him. The Highlanders gave a loud shout and waved their bonnets at the sound of this first discharge of the Prince's cannon. Some of the Duke's dragoons had difficulty with their horses, nervous from the noise, but soon recovered their poise.

Two minutes later the sixteen 3-pounders of the Royal artillery belched out their first deadly missiles. It had been an effort to haul the bogged guns on to firmer ground, but now they were ready and were opening up on the exposed Jacobite line, some 300 yards away. In command of the guns was

Brevet-Colonel William Belford who, having spotted a group of horsemen in the rebel rear through his glass, directed fire in the hope of killing the Prince himself. Charles was unscathed, but a number of men including his groom and some of his hussars were killed. This was the first

time from the outset of the campaign that the Highlanders had been exposed to artillery fire – it had been virtually absent at Prestonpans and Falkirk – and the swirling smoke and the round shot ploughing through their ranks was disconcerting in the extreme. The Jacobite guns responded feebly. Unable to find their targets, within nine minutes most had fallen silent, many of the gunners having fled as soon as the Royal artillery began firing. The smoke from the Royal guns also made it impossible for the Jacobite gunners to range their weapons, although one gun had been dragged to the south-east corner of the enclosure and was still firing. The English cannonade continued relentlessly and more Highlanders fell, but still the order to advance – ‘Claymore!’ – did not come, only the shouts of ‘Close-up! Close-up!’ as more and more gaps appeared in the ragged lines. It is thought that most of the Prince’s casualties were suffered during this bombardment.

The Royal gunners were still trying to locate Charles who was near his standard under the protection of Kilmarnock’s dismounted troopers behind the centre of the second line. Urged to move towards the right wing away from the carnage, he stationed himself on a small hillock near Culchunaig, guarded by Balmerino’s Life Guards and sixteen troopers from Fitz-James’s Horse. In this ill-chosen position, remote from his troops, the nature of the ground and the bad weather prevented him from seeing clearly the unfolding situation. In sole command for the first time, he was so far removed as to be completely ineffectual. His bewilderment at seeing so many of his men cut down and his frustration at the English delay in attacking left him unable to decide what to do next. Watching the destruction with expectant admiration and pride, the men in the English ranks stood still and waited, growing in confidence minute by minute. The wind was at their backs and they could see the smoke blinding and confusing the Highlanders. Cumberland was content to save his infantry and let his guns do the work for them, but he felt sure that the Highlanders’ advance would not be long delayed. Accordingly he made some changes to the deployment of his troops by moving Pulteney’s Regiment from the rear to the right of the front rank in order to counter the

Macdonalds who outflanked the Royal troops. Battersau's men were also brought up from the rear to the second line to fill the right-hand flank should Pulteney's soldiers give way. Thinking that he would not need a reserve, the Duke left a token regiment, Blakeney's, in the rear. Kingston's 200 troopers, joined shortly after by 60 of Cobham's mounted men, were also moved to the right of Pulteney's to prepare for a flanking attack.

Murray had considered a flanking movement against Cumberland on the latter's left wing near the Culwhiniac enclosure, but the Duke had been

quick to realize the threat, feeling that it was there that the balance of the battle would lie. Accordingly, a contingent of Wolfe's Regiment under Major-General John Huske was moved to a position at right angles *en potence* to Barrell's men on the extreme left of the Duke's front line. Here, with their backs to a stone dike wall, they faced down the Royal front rank to enfilade the imminent Highlanders' charge with rapid musketry. The remainder of Cobham's cavalry, 240 men in all, had now linked up with Lord Mark Kerr's 300 troopers to the left of the Leanach barn near the

loyalist Argyll Militia and were awaiting further orders. Cumberland himself had ridden to a position towards the right of the second line in front of Howard's Regiment in anticipation of a flanking movement in that direction from the Macdonalds. Two lines of Redcoats now awaited the next phase of the battle: Cobham's and Kingston's cavalry, Pulteney's, the Royals (St. Clair's), Cholmondeley's, Price's, the Royal Scots Fusiliers (Campbell's), Munro's, and Barrell's, with Wolfe's troops at right angles. A few dozen yards behind them stood the second line of

Battereau's, Howard's, Fleming's, Bligh's, Sem-pill's and Ligonier's Regiments deployed right to left. In the rear towards the left stood Blakeney's Regiment. The extreme left wing was held by the cavalry under Kerr, and the Argyll Militia.

The Highlanders' Charge

The firing continued to cut large swathes through the rebel lines for upwards of twenty minutes, although some accounts estimate the duration of the cannonade at anything from nine to 30

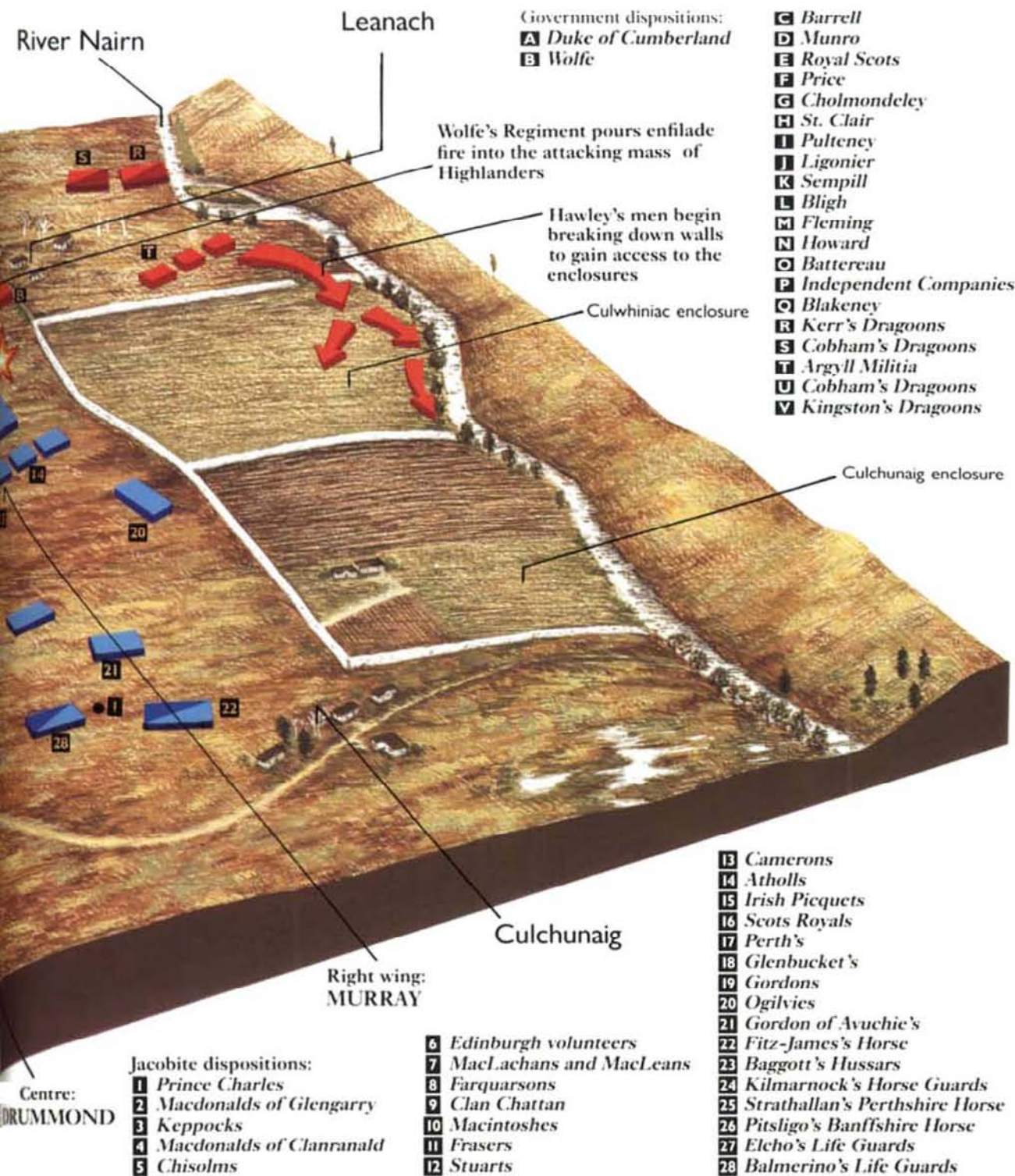

minutes. Belford now changed from shot to grape in the hope of finishing off the enemy. The result was devastating: more and more of the Highlanders in their tightly packed ranks, swelled by men arriving on the field, collapsed dead or wounded under a withering hailstorm of lead pellets from the Royal artillery's front-line guns. Some deliberately fell to the ground to protect themselves; others fled in fear. It was now obvious to O'Sullivan that the army, being weaker in artillery, must charge. For practical purposes his artillery now consisted of a single gun on the right wing and an additional gun which had been brought up by a French engineer to a position at

the south-east corner of the enclosure wall.

Shortly before 1.30 p.m., with a squall of hail and rain lashing the clansmen, the order to charge was given. Lord George Murray, who described the regiments in the front rank as 'so impatient that they were like to break their ranks', had been approached by several clan leaders anxious for a decision and fearful that they would be unable to hold their men much longer amidst the terrible slaughter. The restive Mackintoshes urged their leader, Lochiel, to persuade Murray to order the charge. Murray sent Kerr of Graden to the Prince who consented to the attack. By now the Jacobite line was skewed, the right wing being well in

advance of the left, so Kerr directed the Duke of Perth on the left to move to the attack. Laclan MacLachan, one of Charles's aides-de-camp, was sent to Murray, who was with the Athollmen on

the right, to order the attack, but was killed by round shot before he got to the front. Further delay ensued, while more and more casualties were sustained. Charles then sent Sir John Macdonald to the left and Brigadier Stapleton to the right with orders for the line to advance. The order was received, but the Macdonalds refused and were urged on only a few paces level with the other regiments in the front line.

Some of the Highlanders could wait no longer. In rage and despair the Mackintoshes of the Clan Chattan in the centre 'scrugged' their bonnets over their heads, broke the ragged line and darted forward through the wet heather, spurred-on by

the pipes and by their commander, the yellow-haired Colonel MacGillivray. Grape-shot continued to pepper the oncoming clansmen. At their heels came the men of Atholl and the Camerons who had been positioned on the right of the Clan Chattan, but the direction of their charge changed suddenly towards the left to avoid some walls and towards the firmer ground of an old moor road. At the same time, the Macintoshes veered right to avoid the boggy ground between the two armies,

and possibly forced by the heavy musketry which opened up from the centre of the Royal ranks. Confused and blinded by smoke, many were lost in the mêlée, or fell to the brisk firing from the Royal centre. Survivors later stated that they were caught in thick smoke and became disorientated. The Clan Chattan lost eighteen officers and hundreds of men before getting within twenty yards of the Royal lines. Similarly, the Athollmen were cut down before they had a chance to engage.

They had run broadsides to Wolfe's men lining the wall who decimated them with accurate musket fire. The walls on each flank had a funnelling effect, forcing the charging clansmen into an area little more than 300 yards wide. Undeterred, the dense mass now crammed into this narrow corridor against the park wall and the Leanach dike, and moved towards the left of the Duke's army to engage the men of Barrell's, Munro's and Wolfe's Regiments. In the few seconds it took to cover the

distance, many of the Highlanders, unable to fire their customary volley because of the congestion, discarded their primed muskets and pistols and resorted to the broadsword, scythe blades or axes. For a moment the Prince's soldiers were shrouded in cannon smoke, but as it lifted they saw an orderly line of Redcoats, 30 yards away, who levelled their muskets and fired an accurate and deadly volley; a distinctive counterpoint to the monotonous pounding of Belford's guns which

continued to fire. The troops in the front rank knelt to fire while two other ranks stood behind with muskets raised to shoulder, to providing continuous firing as one line after another re-loaded. The enfilade fire from Wolfe's men in front of the Leanach dike was now beginning to take effect, but the shouting Highlanders came on pell-mell towards the left.

Seeing the pressure on his left wing, Cumberland ordered some of the regiments in the second line to move 50 yards to the left in anticipation of a breakthrough by the Highlanders which was not long in coming. The men of Barrell's and Munro's, having had time for only one volley, raised their muskets with fixed bayonets to meet the onslaught of 1,500 Highlanders who crashed into them full tilt. Many of the English soldiers were seriously wounded including Lord Robert Kerr and Lieutenant-Colonel Rich. According to one account, 'The Highlanders fought like furies and Barrell's behaved like so many heroes.' As the clansmen created a wedge that forced Barrell's 350 men outwards to form on Sempill's, they came to grief on the bayonets of Sempill's and Bligh's Regiments. A soldier of the Royal army wrote, 'Our lads fought more like devils than men. In short we laid . . . about 1,600 dead on the spot . . .'

Sempill's troops were filling the gap behind Barrell's and Munro's men and upon them fell the brunt of the Highlanders' attack but due to the closeness of the English front ranks, many of Sempill's men could not fire with accuracy and a number of Barrell's men may have been shot by their own side. None the less, the English firing was deadly and those clansmen who were not felled by bullets were stopped by the bayonet. 'Give them the bayonet!' was the command. Cumberland's training was paying off. As one Royal officer claimed, the directions 'made an essential difference, staggered the enemy who was not prepared to alter their way of fighting, and destroyed them in a manner rather to be conceived than told'.

The charge petered out with straggling groups of Highlanders running senselessly this way and that between the two lines of Royal troops seeking a way out. A soldier of Cumberland's army recalled the scene: 'About 500 Jacobites pene-

trated the Royal lines. They were forced through our front Line, they were now between two Lines, and our Front completing again, they were severely handled both Ways: for those who escaped the fire of Bligh's and Sempill's Regiments met a worse Destruction from the Bayonets of our first Line, there being scarce one Soldier in Barrell's Regiment who did not each kill several Men . . .'. Few of those who broke through the English lines survived to tell the tale. Lochiel, wounded in both ankles, was carried from the field by two Highlanders while his forlorn Camerons disengaged and began to retreat. In desperation, others threw stones at the Redcoats which amused Cumberland. Those who broke back from the line were swept by Wolfe's muskets and by mortar shells and grape-shot. Lord George Murray had also ridden through the English lines and having been thrown by his horse managed to fight his way back to his men on foot. Realizing that the crisis was upon them, he tried to encourage the second line of Highlanders and some French troops, but it was clear that all was lost.

Towards the centre and left, the Highlanders were faring little better. The advance of the Clan Chattan and others on the right had inspired others to follow. The MacLeans and MacLachlans charged, but – the rebel line being skewed – they had further open ground to cover and none reached the Royal lines; the musket fire from the Royals and Pulteney's was so deadly that no living thing could survive. Of the 200 MacLeans, whose boast it was that they never gave ground, 150 were killed. Keppoch and Macdonnell of Scothouse died in the thick of the action, the latter only twenty paces from the enemy. The dead ground between the two armies was littered with dead and dying clansmen. Less enthusiastic were the Farquharsons and the Macdonalds. Since early morning the Macdonalds of the Glengarry Regiment had been complaining about their placement on the extreme left of the Jacobite line, and the Duke of Perth had tried to placate them. When the Regiment saw the Highlanders' charge on the right and centre they advanced a few paces and began to run towards the Royal lines, firing pistols and waving their swords in the vain hope of tempting the Royal troops to attack. Some fell into

knee-deep water and could advance no further because of the swampy ground. They were swept by musket fire, it being said by Cumberland that his infantry 'hardly took their firelocks from their shoulders' and, seeing activity amongst the Royal cavalry suggesting a flanking movement, started to retrace their steps, just as other clans in their rear began to flee the field. Some officers charged with Keppoch, but many including the leader were

felled by musket balls. A number of the Macdonalds were brought off by picquets before they could be surrounded by Kingston's Horse. The guns of the Royal artillery continued to fire relentlessly and stragglers were still being killed by grape-shot. To add to the slaughter Cobham's 60 troopers and Kingston's Horse moved off from the Royal lines and rode in amongst the fugitives, hacking at them without mercy. The Jacobite lines

were in complete disarray, with gaps left by the fleeing clansmen. The battle had been raging for less than half-an-hour, but the left and centre of the army no longer existed.

The Cavalry Attacks on the Flanks

At the outset of the bombardment, the Campbells of the Argyll Militia were seen to detach themselves from the Duke's army and move towards the enclosed lands around Culwhiniac between the

river and the Jacobite army in order to outflank the Athollmen. In fact, the situation of the Culwhiniac enclosure had been ignored by all the Prince's officers except Murray who had wanted to remove the walls. John O'Sullivan had commented: 'Never fear, my Lord, they can't come between you and the river unless they break the walls of these two parks that are between you and them.' It had been O'Sullivan's feeling that having walls on each flank of the army would guard against encirclement. He had failed to observe the obvious – that walls have

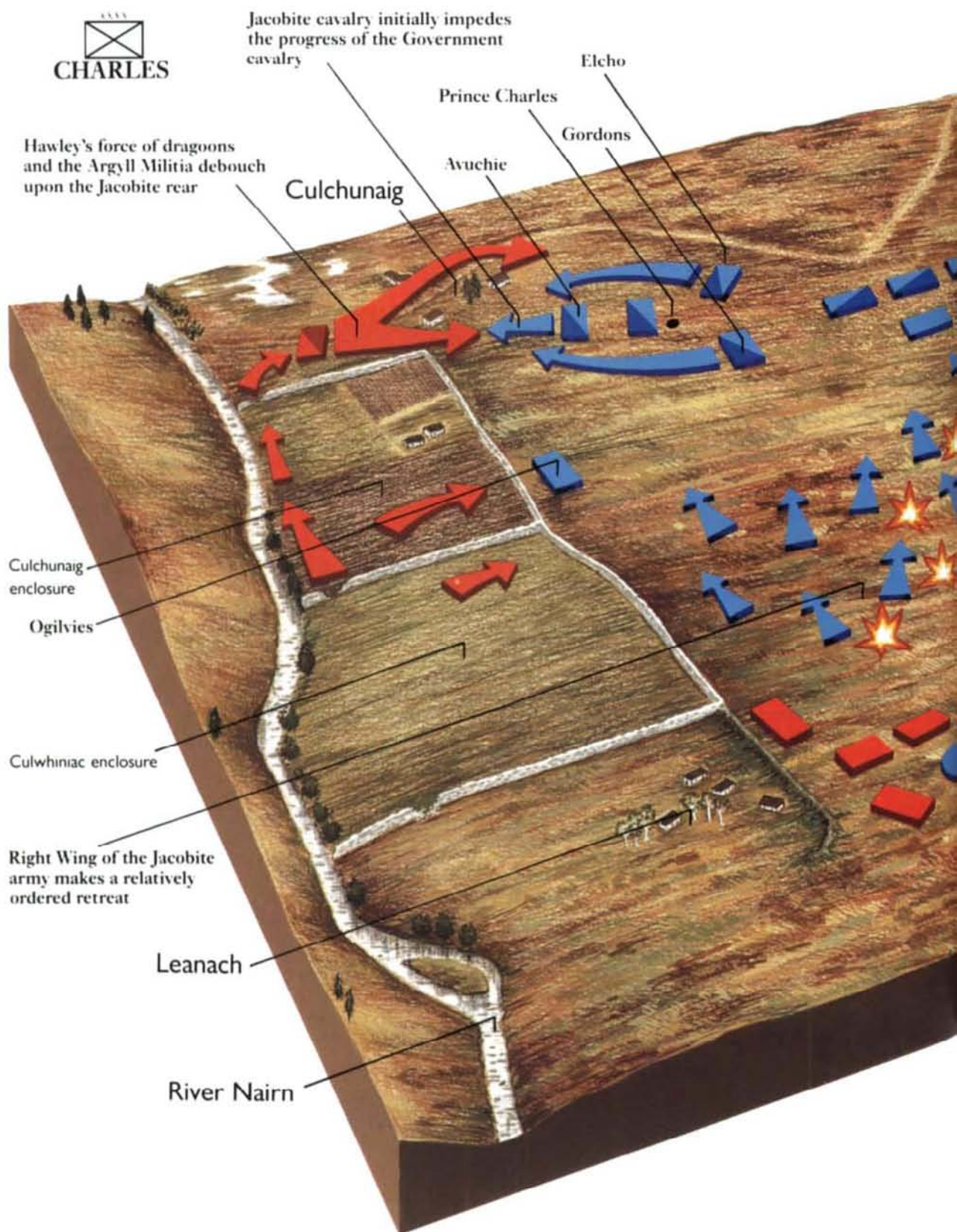
gates, and that the enclosure of Culwhiniac could be by-passed by troops to take the Highland army in the rear. The Duke of Perth wanted to line the walls but Lord George Murray did not have enough soldiers to garrison the enclosures. As an afterthought Ogilvy's Regiment was sent to guard the flank. When two officers were sent to observe the movements in the enclosures – and indeed sighted some dragoons at the far end, they reported back that the river banks were too high to allow mounted troops to approach from that

direction unless they broke down the walls. Murray was now concerned about the presence of the Royal dragoons and ordered Ogilvy to keep a close watch on the position. At the same time O'Sullivan took a hundred men to the north side of the dike.

From the river to the moor, between farms and the East Park of the Culwhiniac farm, ran a sunken lane and here five squadrons of His Majesty's cavalry were biding their time. The Argyll Militiamen armed with axes made a breach at the corner

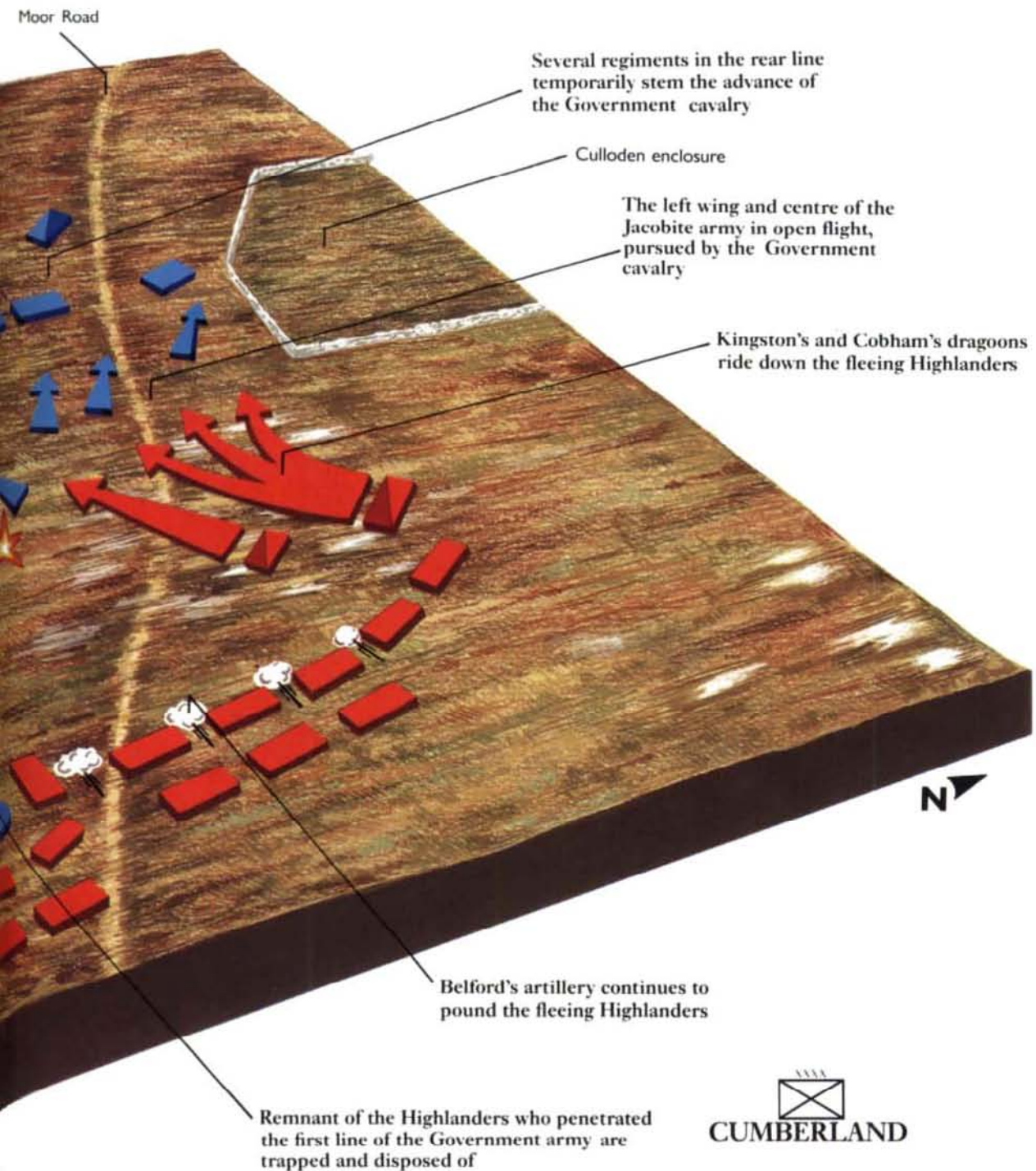

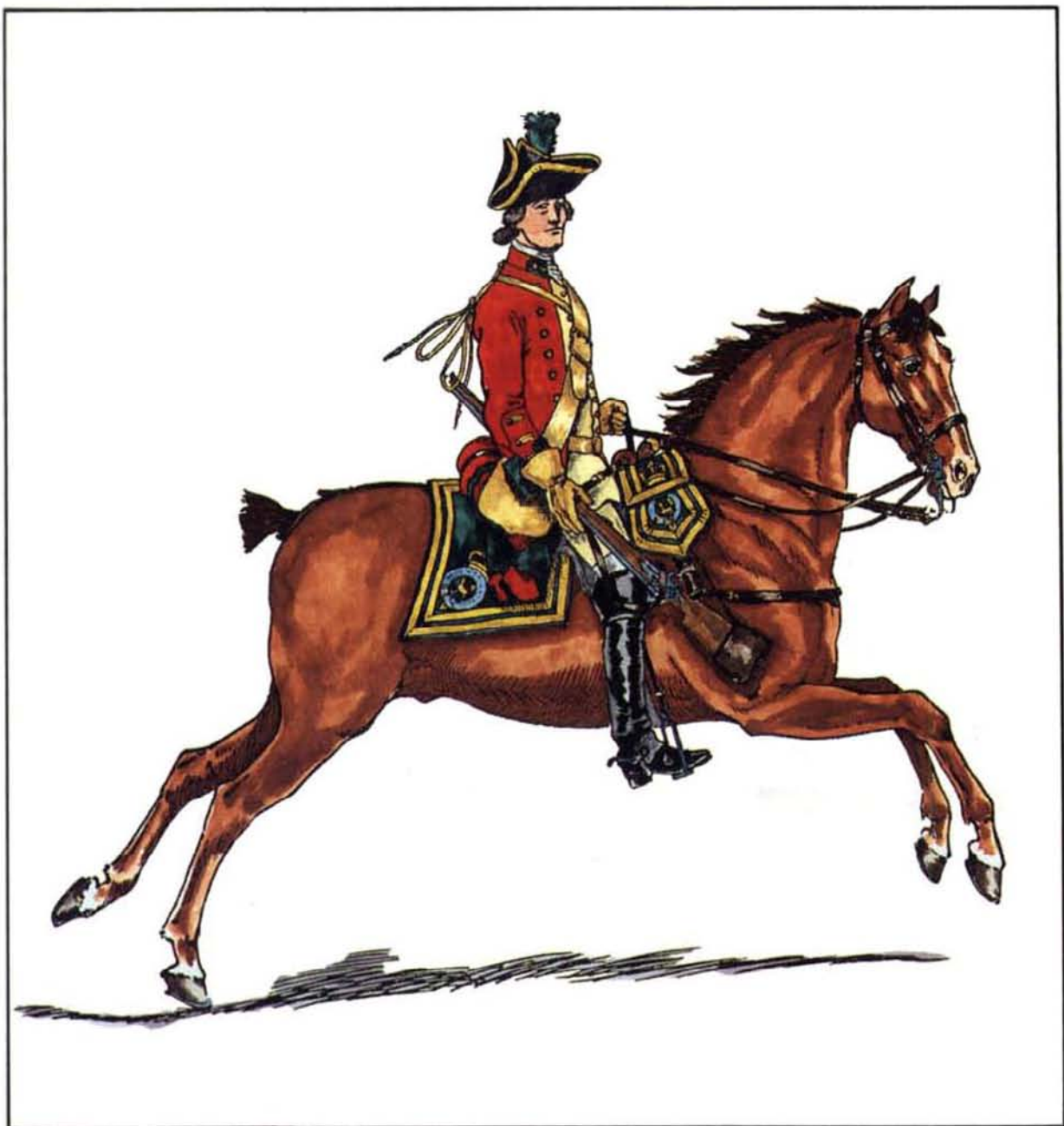

of the walls beside the river and ran westwards along the farthest dike by the Water of Nairn. Another group moved northwards inside the wall which ran parallel with the sunken road. A third group and some dragoons advanced across the East Park of Culwhiniac and it was they who were seen by the Jacobites. Coming to a wall separating the East Park from the West, a second breach was made. To counter the flanking movement, Murray

moved Gordon of Avochie's Battalion in the direction of the Argyll Militia and brought up Fitz-James's Horse to face the threat from the Duke's cavalry. Some Campbells began to fire upon the fleeing Jacobites, particularly the Camerons, and charged out of the park with raised swords, losing half-a-dozen men and two officers in the process. Cobham's and Kerr's dragoons, about 500 well-armed and disciplined troopers in ten squadrons,



led by Hawley, having gained access through the torn down walls began the flanking movement on the left. Some opposition was encountered from clansmen of Avochie's Battalion, but they were soon dispersed and the dragoons moved into position near some houses at Culchunaig. In fact, Murray later stated that the enemy approached without being fired on by Ogilvy's Regiment who were originally lining the wall, but who for some

unknown reason had been withdrawn to form a reserve with orders not to fire unless directed to do so. Misunderstanding or not, it was probably the worst single order of the entire battle and allowed the Royal cavalry to outflank the Jacobite right wing virtually unmolested.

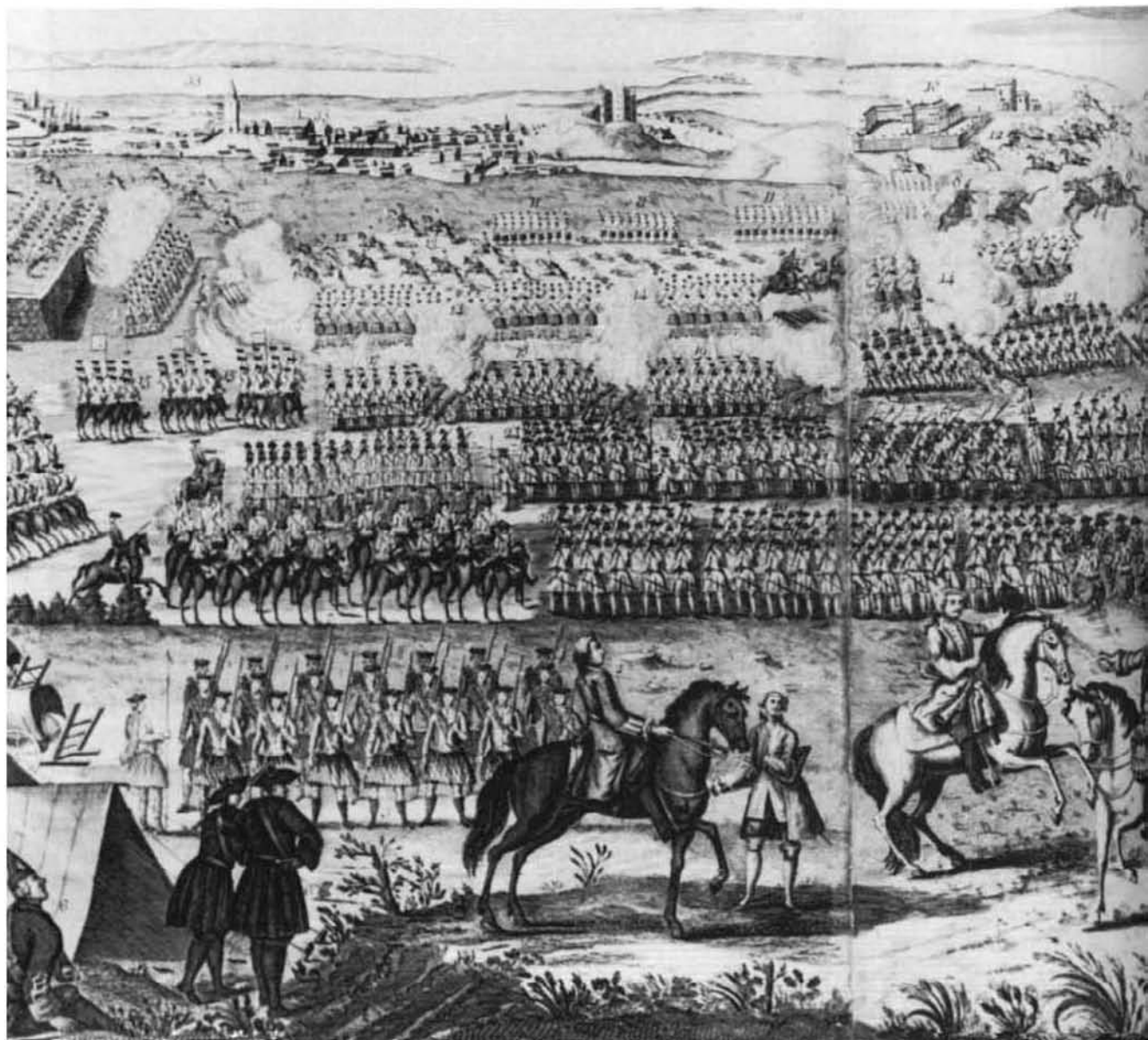
The Prince's cavalry of Elcho's Life Guards and Fitz-James's Horse formed up to oppose the Royal threat in the enclosures. This dishevelled

remnant of about 160 men, from an original contingent of 400 troopers, riding tired and hungry mounts, were unable to charge because of the boggy ground, but they plunged into the Royal cavalry as it moved along the sunken road, inflicting some losses with pistol and carbine fire. But they were no match for trained cavalymen. It would have been easy enough for the Royal cavalry to remove this threat, but they were reluctant to press on, preferring instead to advance at a slow pace. It had been a vain attempt but it nevertheless provided valuable time for the Prince's right wing to make an orderly retreat. In fact, for ten vital minutes, the Jacobite cavalry under Lord Elcho and Colonel O'Shea delayed the Royal cavalry

from gaining access to the moor where they could have massacred the fleeing Highlanders. When Hawley's men did break out, Fitz-James's Horse retreated to form a protective square around their fleeing comrades. The Prince's other cavalry, the

Perthshire Horse and some hussars, failed to attack but one of their leaders, Lord Strathallan, charged headlong towards some English troops but was killed instantly by Colonel Howard.

The right wing of the Highland army was now making a hasty retreat in an orderly fashion considering the circumstances. Credit must be given to Lord George Murray and Lord Ogilvy with two battalions of Angus men. Like Fitz-James's Horse, they organized themselves into a square formation, frequently turning round to fend off Royal troopers. Legend has it that on one occasion during the retreat some clansmen were confronted by a party of Royal cavalry who moved out of their way and allowed them to pass

unmolested. Certainly it was known that Hawley's cavalry were reluctant to attack Jacobites in formation, preferring instead to tackle the stragglers and wounded.

As Cobham's and Kerr's men moved on to the moor and commenced their butchery, the Jacobite left wing – in contrast to the right – was beginning its retreat in great disorder, harassed by Kingston's Horse who were moving round to meet up with the English cavalry from the left wing. They attacked the Royal Scots who had been in the centre of the Highland line while Cobham's cavalry attacked them from the rear. Fortunately for the Scots, the Irish Picquets prevented a complete encirclement with a steady fire, which saved almost one hundred lives, until they themselves were forced to seek cover behind a wall, before quitting the field for Inverness. The guns were still pounding away as Cumberland and his staff contented themselves with watching the ensuing slaughter.

Several hundred yards away, Prince Charles had observed the pending crisis in the enclosures, but had sent no reinforcements, and as his cavalry gave way, he was escorted away from the fray at the suggestion of O'Sullivan who, acknowledging that all was lost, exclaimed, 'Yu see all is going to pot. Yu can be of no great succor, so before a general deroute which will soon be, seize the Prince and take him off.' Charles was so far back that there was never any danger of being captured, but he left the field in the direction of Balvraid accompanied by the remnant of two Highland Regiments, Glenbucket's and John Roy Stewart's. Disillusioned at the sight of fleeing soldiers (probably from the left wing) whom he had thought invincible, he tried to persuade them to attempt one more charge, offering to dismount and lead them in person. 'Rally, in the name of God. Pray, gentlemen, return,' he shouted, but few paid heed to his urging, and his companions begged him to consider his own safety. Among the last to leave Drummoissie Moor were the French and Irish troops. In just under one hour the flower of Scotland had been overwhelmingly crushed. With the exception of Lord Nairn, Murray and Charles Stuart Ardsheel, most of the Jacobite commanders were dead or wounded, and one-third of all the men from the regiments in the centre or right wing



were dead. Indeed, of the men who had charged with the Mackintoshes, only three survived.

The Pursuit

While Charles was making his way towards the ford of Faillie over the Nairn, the Royal cavalry from both wings were riding together all over Drummoissie Moor, cutting at anything that moved before pursuing the fleeing Jacobites towards the road to Ruthven. At the ford Charles, who was 'in a deplorable state', convinced that treachery had lost the battle, met Elcho and O'Sullivan to plan the next move. The sight of more Jacobite officers fleeing made him even more despondent. It was decided to move towards Fraser country, but orders sent to Highland officers asking them to assemble at Ruthven were quickly changed, and they were told to disperse.

Meanwhile the fields around Culloden House were searched for fugitives by Kingston's troopers

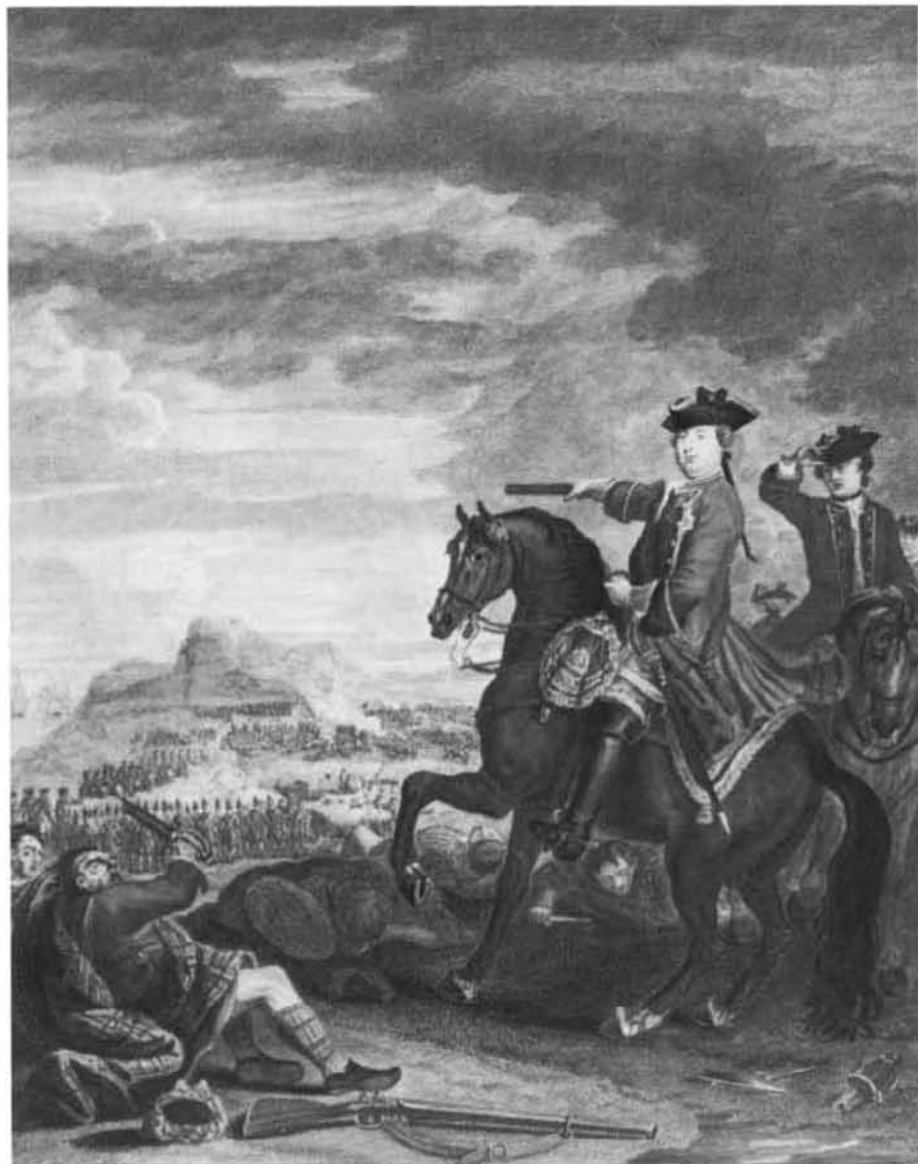
before they headed down the road to Inverness, chasing fleeing Highlanders and sabreing any who stood their ground. These cavalymen were vengeful following an incident earlier in the month when they had been surprised by Jacobites at Keith. A participant described the present scene: 'Immediately our Horse that was on the right and left wings pursued them with sword and pistol and cut a great many of them down so I never saw a small field so thick with dead.' Many non-combatants were slaughtered including two weavers at Ballavrat, a blacksmith, and a father and son ploughing in a field. An estimated 1,500 Highlanders, having slept through the battle, came from cottages and fields to swell the rout. It was not long before the clatter of hooves on paving stones announced the arrival of the Royal cavalry. Dismounting, they demanded food and lodgings. The remnant of the Highland army, mostly those who had been on the right and centre of the line, moved off with colours flying and pipes playing towards Balvraid and on

to the ford of Faillie, four miles from the battlefield, under the guidance of Murray and the protection of Lord Ogilvy's two Angus Battalions which fought several rearguard actions against the Royal cavalry. From there they moved southwards into hilly country where it would be easier to avoid harassment.

On the moor, the guns fell silent for the first time in an hour. Now all that could be heard were the cries of the wounded in the heather, and the shouting and clatter of the Royal army as it prepared to advance. Shortly afterwards naval ships riding in the Moray Firth began to fire

salutes to the success of the army. Riding eastwards went one of Cumberland's aides, bound for Fort George and a Royal Navy ship which would carry the news of the victory to London. The Duke himself now moved forward through the front lines of his tired but jubilant troops, thanking each regiment for its efforts and ordering immediate refreshments to be handed out. In return he received loud 'huzzas' from his men, who shouted 'Billy! Billy!' and 'Flanders! Flanders!' The Duke then took up his position on the right and the order was given for a general advance, though the men of Barrell's and Munro's Regiments were allowed

to stay where they were to tend their wounded. Marching the few hundred yards which had separated the two armies, the Royalists halted on the line where the Prince's regiments had deployed a few hours before. Again the troops cheered before sitting down to eat supplies brought up by the wagons. Having finished their brief repast, some of the soldiers rose and proceeded to bayonet any wounded Highlanders they could find. The Duke himself is said to have taken his lunch sitting on a stone at the eastern edge of the field. Although some of Cumberland's men were humane, there was a general tendency to show no mercy, especially in view of the captured note which, it was alleged, directed the Highland army to 'give no quarter, to the enemy'. Elsewhere on the field dragoons and foot were urged by General Hawley to kill any wounded Scotsmen. One English witness wrote: 'The moor was covered with blood and our men, what with killing the enemy, dabbling their feet in the blood, and splashing it about one another, looked like so many butchers rather than Christian soldiers.' A young wounded Highland officer gazed at Hawley who immediately ordered him to be killed. Legend has it that young James Wolfe, who was serving on Hawley's staff, refused to carry out the order and a soldier was found to do the job. Some of the Prince's commanders decided to place their fate in the hands of the enemy. Lord Balmerino, for one, refused Lord Elcho's plea to follow him off the field, and rode towards the enemy knowing full well the fate that awaited him. Lord Kilmarnock mistook some Royal dragoons for his own regiment and was immediately captured. Strathallan preferred to die rather than submit and, gathering some of his men around him, rode directly towards Cobham's dragoons, where he met his death by the sword of Colonel Howard.

After the battle Gillies MacBean had crawled to a wall six hundred yards from the field where several Royal troopers cut him down. In his last moments of life he dragged himself to a barn and died on the straw. Another Highlander tried in vain to keep the dragoons at bay with a pole from a wagon. John Fraser, an ensign in Lovat's Regiment, had been shot through the thigh and taken prisoner. He was taken to a nearby house

with other prisoners. Three days later they were taken to a field and shot. Fraser, though badly wounded and left for dead, managed to crawl to a nearby cottage where he recovered. Even innocent bystanders were not immune from the terror. Alexander Munro had gone to Drummossie to watch the battle but, given the confusion, decided to go to Inverness instead. On the way he and his companion were overtaken by dragoons. Munro ran into a field where he was cornered by a horseman whom he managed to bring down with a sword he had picked up near the battlefield.

The Royal army moved off in the direction of

Inverness early in the afternoon. Along the road, a Jacobite drummer approached the Duke with an offer of surrender from General Stapleton who had commanded the Irish Picquets. Cumberland sent the messenger back with a letter assuring the General of fair treatment. The first infantry troops to enter the town were men from Sempill's Regiment under Captain Campbell who presented a strange appearance to the townspeople on account of the various assortment of hats and feathers removed from the Jacobite dead and now adorning the heads of the English soldiers. Shortly afterwards a group of dragoons entered the town with Cumberland as church bells rang and loud cheering filled the air. Loyalist prisoners, mostly Argyll Militiamen, were released from the prison

and given a guinea each as compensation for their incarceration. Jacobite soldiers took their place. The last troops entered the town at about 4 o'clock. The wounded men, 259 in all, were given twelve guineas each from the Duke's own coffers while soldiers who had captured enemy standards received sixteen guineas. Tired from his bloody work, the Duke sought lodging in the home of Lady Macintosh, where two nights previously Prince Charles had stayed. Less than six miles away the wounded and dying clansmen lay on the soaking wet moor unattended by the Royal army surgeons who believed that English wounded had been neglected by the Jacobites at Prestonpans. Three ladies from Inverness ventured out to tend the wounded.

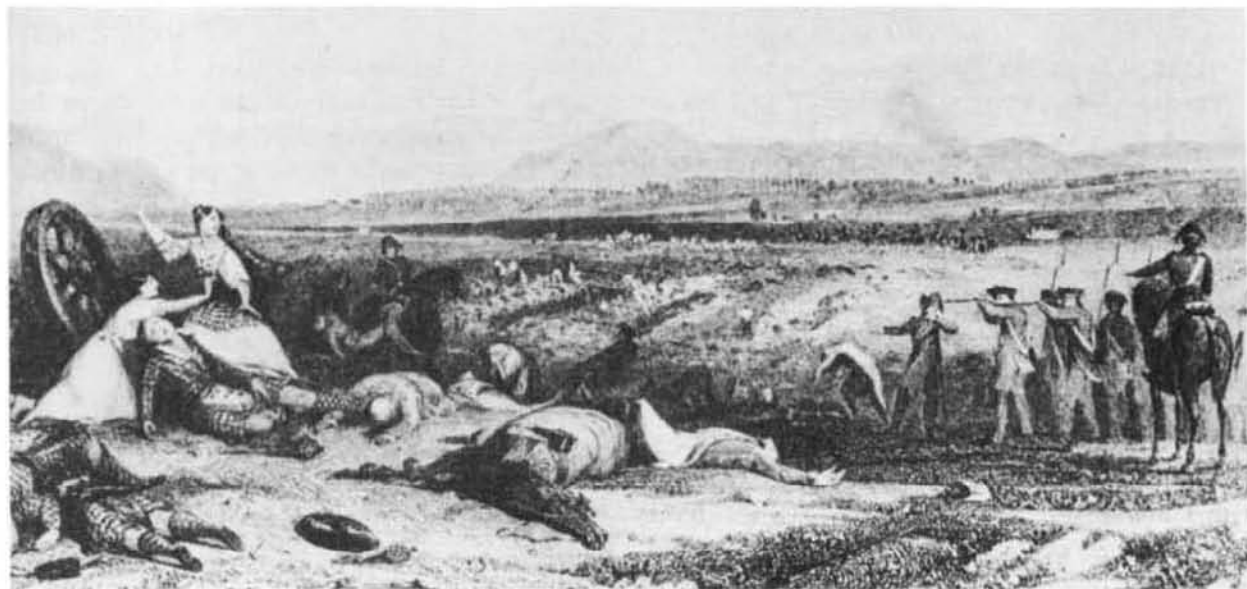

THE AFTERMATH OF THE BATTLE

On the morning of Thursday 17 April, the dead soldiers of the Royal army were buried within an enclosure on Drummossie Moor. The army that had crossed the Spey had numbered approximately 8,811 men, of whom 6,411 were infantrymen. Casualties were given as 50 dead and 259 wounded. Of the officers, Lord Robert Kerr had been killed; Colonel Rich, who had commanded Barrell's, had lost a hand and was badly cut about the head, and a number of captains and lieutenants had been wounded. The brunt of the casualties were borne by the 438 men of Barrell's Regiment, seventeen of whom were killed and 108 wounded. In contrast, two regiments from the first line, two from the second line and one from reserve, together with the main group of Campbells, never fired a shot. It has been said that of the 14,000 belligerents at Culloden, possibly fewer than 3,000 men actually fought, the others either not having been called upon, as was the case of these English regiments, or fleeing the field, as many Highlanders did.

While the burial parties dug into the soggy ground they were aware of numerous wounded Highlanders still on the moor and as many as could be found were hastily dispatched. Drummossie and the surrounding fields and roads were strewn with Jacobite dead and although a count was made of the bodies, the government estimates may have been inaccurate; many of the wounded managed to hide from the Redcoats or died in cottages or barns. On the Friday after the battle, many were rounded up and executed by firing-squad. Cumberland ordered that all cottages in the neighbourhood of Culloden be searched for rebels: 'The officers and men will take notice that the Public orders of the rebels yesterday was to give us no quarter,' a claim which had no foundation. Of approximately 6,000 clansmen present with Prince Charles on 16 April, 2,000 may have become casualties. Some 336 Jacobites and 222 French were taken to Inverness and incarcerated in the gaol and in cellars of houses. More prisoners, mostly deserters from the Duke's

army were hanged from hastily erected gallows.

In Inverness, the Duke awoke early on the Thursday morning invigorated from the previous day's work. His task now was to prepare plans for the policing of the Highlands and the elimination of Jacobitism. 'All the good we have done is a little blood-letting, which has only weakened the madness, not cured it. I tremble for fear that this vile spot may still be the ruin of this island and our family,' he wrote. He was to spend the next three months in the town, directing his soldiers in their dirty work. Likewise, General Hawley was busy

issuing orders for the extermination of the wounded Highlanders out on the moor.

Several miles away, the defeated Jacobite troops continued their withdrawal into the hills. There were still about 2,000 men under arms and they could have waged a guerrilla war, but no leader could be found. Charles had spent the evening after the battle at Gorthlick, fifteen miles from Culloden, but was preparing to rendezvous with a number of his soldiers at Fort Augustus. The majority of the fugitives, with Lord George Murray, Drummond, Perth and other leading

Jacobite officers, had gone in the direction of Ruthven, however, believing this to be the rallying place. And so Charles, cut off from the main Jacobite force, moved off westwards towards the coast, leaving a last brief command for his supporters: 'Let every man seek his own safety the best way he can.' At Ruthven, the Highlanders simply dispersed and went their own way, Murray penning a somewhat critical note to the Prince suggesting that the cause had been plagued from the beginning and that had the right field of battle been chosen and adequate supplies been to hand, the vanquished might have been the victors. Several weeks passed before Charles received the letter and from that time onwards he never forgave Murray.

As Charles Stuart headed for the Outer Hebrides, a number of his supporters, Lochiel in particular, still had ambitions to resist the enemy from the hills and a gathering was planned near Loch Arkaig, but less than six hundred men showed up. Ironically, two French privateers, *Mars* and *Bellona*, loaded with money to support the

Rebellion, managed to reach the Scottish islands, having eluded three Royal Naval vessels. When they returned to France their passengers included several leading Jacobites, but Murray was not among them. He had set off towards the east coast but fell into the hands of Cumberland's dragoons at Polmood in the borders. After years of imprisonment in England he was released, having shifted his allegiance to the Hanoverians. He spent the last thirty years of his life in Hertfordshire.

On 20 April the Prince and several close associates including O'Sullivan reached Arisaig, almost nine months after putting ashore on that fateful July day. After spending a few days on the coast he gave his final address to his supporters before leaving in a small boat on the 26th. They landed on the small island of Benbecula in the Outer Hebrides, and word of his arrival quickly spread throughout the small communities. Royal ships and troops were combing the islands, so the Prince set off again towards Scalpay between Harris and Lewis, and then on to Stornoway. Thereafter he was constantly on the move al-



though he did spend three weeks at Corradale on South Uist. On 13 June he found himself within two miles of Cumberland's soldiers, and he was again forced to put to sea at Loch Boisdale. It was during this erratic itinerary that Charles was assisted by Flora Macdonald whom he had met at Milton on South Uist, and it was she who accompanied him to Skye, with the Prince disguised as a woman. The price on the Prince's head was tempting to many local lairds in the islands, and one in particular, Sir Alexander Macdonald, planned to betray him but was thwarted by the Prince's departure for Skye. Flora Macdonald was later arrested in Skye and imprisoned but released the following year. Charles sailed to the island of Raasay on 1 July and eventually made his way back to the mainland, constantly moving to avoid capture. Eventually, on 19 September, he and his colleagues reached Borrodale where two small French vessels were ready to take them to France and exile. In 1788, drunken and disillusioned, the Prince died in Rome.

During Cumberland's stay in Inverness the Royal troops penetrated deeper into the Highlands in their search for the Prince. The Duke moved to Fort Augustus with the bulk of his army leaving four battalions at Inverness to guard the north. Three infantry battalions held the rebels in check in Perthshire and Aberdeenshire, and the west was

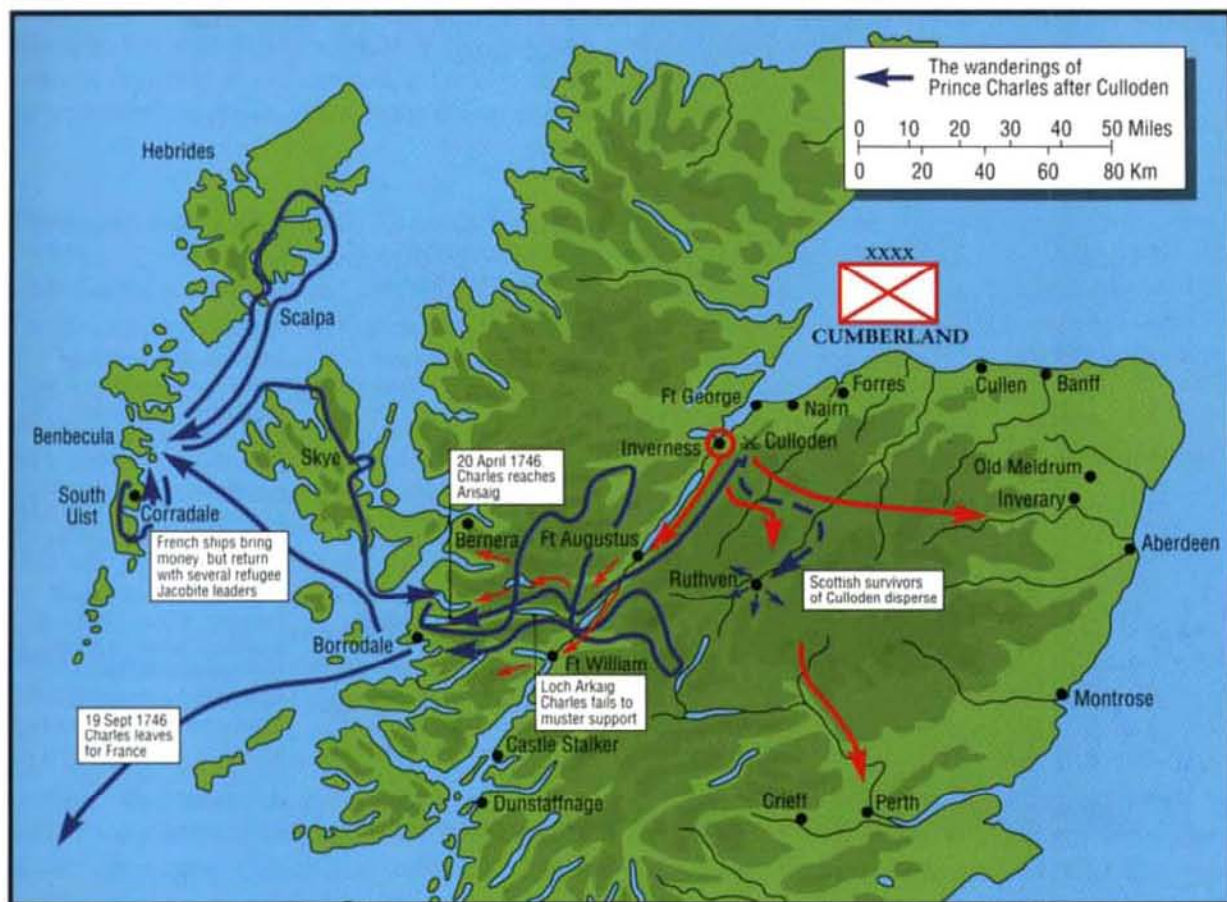
policed by a large garrison at Fort William. In Argyllshire, 2,000 loyalist Campbells ruthlessly stamped out pockets of Jacobite resistance. There were many atrocious incidents although once in a while it was the Royal troops who were the victims. Behind the barracks at Fort Augustus, the bodies of nine soldiers were found, which spurred the Royal troops to ever worse reprisals.

When Cumberland returned to London he was treated as a hero, receiving honours and money and being lionized by society. The cheering of the throngs who came to welcome the 'conquering hero' must have been heard by the Jacobite prisoners held in the Tower. In all, 3,470 had been taken into custody, some just for wishing the Highlanders success. The executions on Tower Hill followed soon, including those of Kilmarnock and Balmerino who were beheaded. Others were hanged, drawn and quartered. A fate (some said) worse than death – transportation to the colonies to be sold – awaited 936 Scotsmen. Some were banished, others simply disappeared, their fate unknown. In Scotland, the Disarming Acts brought a brief end to the wearing of Highland dress and the use of bagpipes. Clan chiefs were reduced by other acts to becoming ordinary landlords, overseeing remote and desolate moorlands. In short the Scottish way of life was eliminated, but it gradually re-emerged in the late

eighteenth century although in a modified form. 'Butcher' Cumberland did not live to see the brief renaissance of Scottish culture; he died on 31 October 1765. His crowning glory had been Culloden, but he was never forgiven for the crimes committed in his name after the battle.

The outcome of Culloden might have been much different had Charles paid heed to his advisers, in particular Murray, and not to the hot-headed O'Sullivan. The Prince was an indifferent commander and the odds were against him before the first shot had been fired. Had the battle been fought at the site suggested by Murray on 17 April, who knows what might have happened? But in his stubbornness lay the seeds of his own destruction. His obsession with the notion that to retreat from one's enemy was unchivalrous doomed his army to fight on ground that favoured the enemy. If the

walls of Culloden Park been knocked down the major threat to the Jacobite wings would have been eliminated. O'Sullivan felt that the removal of the walls would have distorted the Jacobite lines, but in fact the walls served to immobilize large elements of the Highland army. A bad situation was exacerbated by the abysmal standard of communications between the Jacobite regiments. It was stated that the Prince sent the order to attack eight times to Murray before the order was acted upon.

To this day, the name Culloden conjures varying emotions in Britain. The Scottish nation has never forgotten the dreadful aftermath of the battle, which is recalled in numerous ballads. Books and films have added to the mystique, but the barbarism to which the Scots were subjected after the battle left a permanent stain on the British

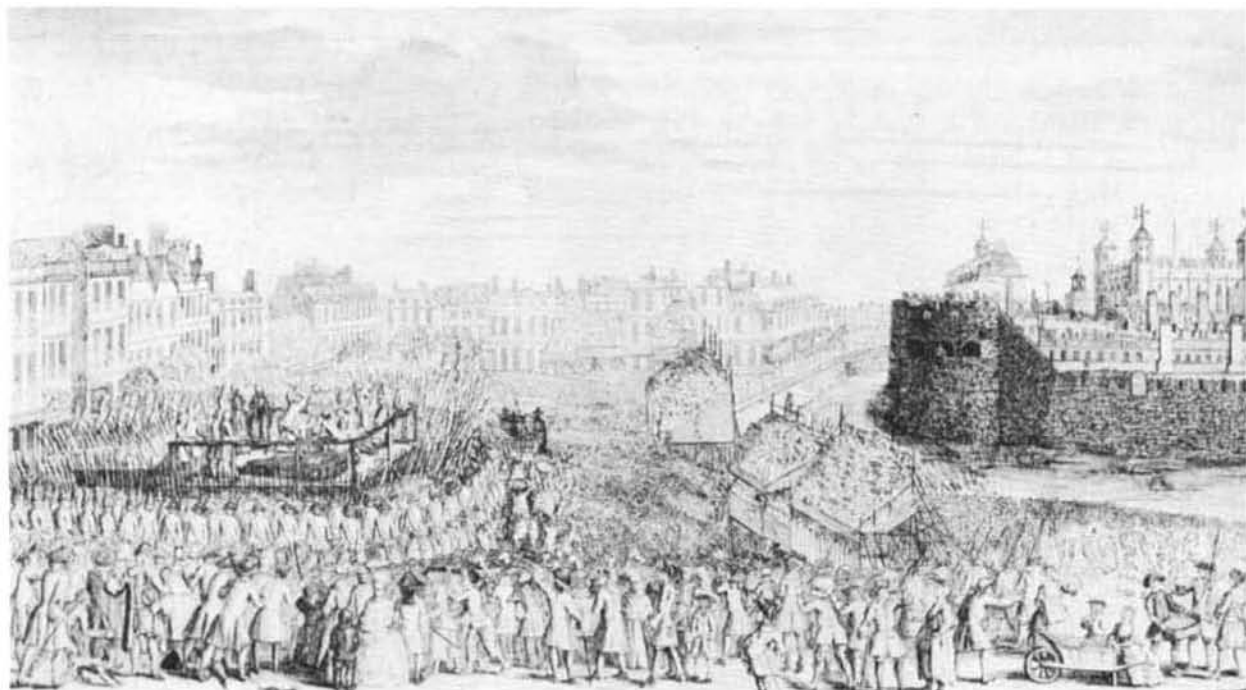


Army and no regiment has ever claimed the right to the battle honour, preferring instead to play down their role in the business. It was the last battle fought by armies on British soil and one which created a lasting ill-will between the two nations which even today emerges from time to time.

THE BATTLEFIELD TODAY

During the last decade, under the auspices of the National Trust for Scotland the battlefield of Culloden has undergone various changes to return the site to its appearance on that day in April 1746. For most of the last hundred years the field had been partly covered under Forestry Commission plantation, leaving only a strip of open ground. This obliterated the overall perspective of the field and blocked the view of the distant Moray Firth and the mountains of Ross and Sutherland to the far north. Fortunately this has now been rectified.

The battlefield is reached by taking the A9 road eastward out of Inverness in the direction of Perth. Five miles south-east of the city is the minor B9006 road, which will bring you to the field, the various monuments and the museum. Originally this was housed in the thatched Old Leanach Cottage, which survived the battle, but a modern visitors' centre, built and expanded in the 1970s, is now open from May to September and has an audio-visual programme. Old Leanach Cottage itself has been furnished as it might have been in 1746, but the surrounding outbuildings wherein one of the atrocities took place – the burning alive of 30 Jacobites – have long since gone. Along the path, several yards from the cottage, stands the English Stone bearing the carved inscription 'The English were buried here'. The records state that the dead from the Royal army, about 50 in all, were buried within an enclosure on the moor, but no graves or trenches have ever been located, although bones were ploughed up in this vicinity in the nineteenth century. The large number of Campbell Militia who were killed when they charged out of an enclosure were buried where they fell.

Continuing along the path westward, the next monument is the Well of the Dead on the spot where the body of Alexander MacGillivray, who led the men of the Clan Chattan, was found. A

carved inscription reads, 'Well of the Dead: Here the Chief of the MacGillivrays Fell.' The majority of the grave markers erected in 1881, however, lie on each side of the B9006, which follows the line of a road built in 1835. Some of these markers have disappeared over time. The stones bear the carved names of the various clan participants, such as Fraser, Stewart and Cameron. The graves are beneath several green mounds, and local belief suggests that heather will never grow on the tops of these rises. Whether these mounds represent the true resting place of those indicated on the markers is open to conjecture, but the fact that the Jacobite dead were buried by local people under orders from the Royal troops suggests that they would have been able to identify the various clans from the different clan devices. One trench, apparently bearing the remains of the MacKintoshes, who lost heavily in the battle, is 54 yards long. As for the Royal forces, the Trust has placed wooden signs where the various regiments stood.

Standing at the centre of the battlefield is the very prominent Memorial Cairn erected in 1881. It stands 20 feet high and bears an inscription that reads: 'The Battle of Culloden Was Fought On This Moor 16th April, 1746. The Graves Of The Gallant Highlanders Who Fought For Scotland and Prince Charlie Are Marked By The Names Of Their Clans.' This is the site of an annual commemoration service held by the Gaelic Society of Inverness on the nearest Saturday to 16 April. To the north-west of the cairn is the Keppoch Stone. This is probably not a burial marker, but legend has it that it is the spot where Alasdair MacDonell, Chief of the Keppoch Clan, fell during the action.

Returning to the B9006, walk westwards away from the Memorial Cairn about half a mile to a group of sites. By the road stands the Irish Memorial, erected in 1963 by the Military History

Society of Ireland, to commemorate the Irish soldiers in the service of France who fought so bravely under their commander, Brigadier Stapleton, to cover the retreat of the Highlanders. Following the battle, the men were treated as prisoners-of-war because they were serving the French king. Close by stands the eighteenth-century King's Stables Cottage, another building owned by the National Trust for Scotland. Near this site the Royal dragoons encamped for several days after the fight.

Backtrack towards the cross-roads just after the Irish Memorial and turn southwards down the small road until you come to the Prince's Stone, lying in a private field to the north-west of Culchunaig. This may mark the place to which Charles moved for safety. The place where the Duke allegedly watched the battle is the Cumberland Stone, a large boulder on the eastern edge of the battlefield beyond the Visitors' Centre and opposite the Keppoch Inn.

The enclosure walls of Culloden to the north-west and Culloden Park to the south-east have been lost because the field has been heavily cultivated since the battle and many walls have been removed or re-aligned. Culloden House was

demolished in 1772 to make way for a stately manor house, but the cellars of the old house survive. Relics of the battle were stored in the house but were sold in 1897, Queen Victoria purchasing Charles's walking-stick.

In Inverness Museum, other relics of the battle and the Rebellion can be seen. Of the forts built by the Government, little can be seen. Fort Augustus, virtually destroyed by the Jacobites in March 1746, was demolished and later built over, and the site of Fort George lies below the rebuilt castle at Inverness. The modern Fort George at Ardersier replaced the fort in Inverness, which was blown up by the Jacobites, but this structure dates from the late eighteenth century. Nothing remains of Fort William, although there is an interesting collection of relics from the Rebellion at the West Highland Museum in the town of Fort William. The ruins of Ruthven Barracks at Badenoch are maintained by the Scottish Development Department.

The related battlefields of the '45 – Prestonpans and Falkirk – are very disappointing, the first being mainly under industrial development, and the second around a park in a residential area. One or two monuments to the battles do exist.

16 July 1745 Charles Edward Stuart sets sail from France.

25 July The French ships *Du Teillay* and *Elizabeth* anchor off the Scottish mainland near Arisaig.

3 August Charles lands in Scotland.

19 August Charles raises the Stuart Royal Standard at Glenfinnan.

17 September The Prince enters Edinburgh.

21 September The Battle of Prestonpans – defeat of Cope.

21 September to 1 November Jacobite army in Edinburgh.

8 November Invasion of England.

5 December The Prince at Derby – decision to retreat.

17 January 1746 The Battle of Falkirk – defeat of Hawley.

30 January Cumberland arrives at Leith.

WARGAMING THE 'FORTY-FIVE'

The story of The '45 has long been a rich source of inspiration for the popular historian. Wargamers are themselves a sub-breed of this species so it is hardly surprising that these same elements of romantic adventure, dramatic turns of fortune and exotically clad warriors lead many to thoughts of table-top Cullodens. But there are a range of options open to the wargamer who wishes to recreate this fascinating period, and what follows is based on the author's experience of designing a number of very different games inspired by the Jacobite Rebellions.

Tactical Level Games: Battles

The traditional battle wargame with miniature figures is the first resort for most wargamers, the only resort for some, but probably the most visually appealing for all concerned. Few figure designers can resist adding a selection of Highlanders to any eighteenth-century range, so the wargamer prepared to hazard his eyesight with the painting of several hundred kilts has an extensive choice of material. Most wargamers will turn to The '45 as a sideline to an existing interest in the 'Horse and Musket' period, but anyone used to the elaborate, all-arms manoeuvres of conventional eighteenth-century warfare will find the tactical possibilities of the battles of The '45 rather limited. The Highlanders' charge was (literally) a one-shot weapon – either spectacularly successful, or an abject failure, and the battles of the campaign were invariably decided in a sudden flurry of activity, and all over in about half-an-hour.

This has two consequences. First, standard sets of eighteenth-century rules, designed with large actions like Fontenoy or Leuthen in mind, will be inappropriate. Secondly, any specially written rules which accurately reproduce the battles are unlikely to give games that are tactically

interesting enough to bear too much repetition.

So although a set of home-produced, 'period-specific' rules are the only realistic option, the wargamer should recognize that this period is probably not going to hold his attention for very long. He should choose how to allocate his resources (in buying figures) and time (in painting figures and writing rules) accordingly.

The tactical problems posed by the Highland charge need to be looked at from both sides of the battle lines. From the Redcoats' point of view, as General Hawley recognized in his pre-Falkirk memorandum, the fire discipline of the infantry is all-important. A first volley, delivered at too great a range, will not halt the charge, and will quickly degenerate into erratic and scattered fire which will be even less effective. On the other side, advancing Highlanders will be endeavouring to provoke just such an early fire, either by the psychological effect of their blood-curdling yells or by deliberately opening fire on the move to tempt an early reply. Morale, training and luck should together determine what happens, and a 'Fire Discipline' dice table ought to be at the heart of the rules.

On the Redcoat side I would suggest three classes of troops:

Veterans: troops who have previously fought a successful action against Highlanders (e.g., Barrrell's Regiment at Culloden, following their successful stand at Falkirk)

Trained: Troops with battle experience elsewhere (e.g., the regiments shipped over from Flanders)

Raw: Newly raised regiments or troops without recent battle experience (e.g., Cope's entire army at Prestonpans). Militia should also come into this category, with a further 'minus' or two on any fire discipline and morale throws.

On the Jacobite side the rule writer should avoid the mistake of assuming that all units are

equally ferocious. The various clan regiments displayed differing levels of enthusiasm for battle, and mechanisms might be devised that involve the Jacobite player in actively raising the morale of his troops before battle. The situation is akin to a Dark Age or Ancient army, and rules for those periods can successfully be adapted.

Indeed, the analogy can be taken further and the example of Colonial wargames used to produce a suitable sense of 'culture shock'. Prestonpan, as the first battle in the campaign, is particularly suitable for this treatment and set up as a 'disguised scenario', with Redcoats in pith helmets instead of tricornes and 'Fuzzy Wuzzy' rather than Highland swordsmen, it is almost guaranteed to produce in the mind of the British player a sense of shock and bewilderment akin to that felt by the unfortunate General Cope.

Tactical Level Games: Skirmishes

Some of the smaller actions of The '45 are, arguably, more tactically interesting, from a wargamer's point of view, than the set-piece battles. The minor tussles between cavalry outposts on the retreat from Derby would make for interesting little actions on a 1 figure = 1 man level, and on a slightly larger scale the 'Sunday Hunting', in which the Duke of Perth's Jacobite hussars were harried by the squires and gamekeepers in Cumberland, offers some entertaining possibilities. The skirmish at Clifton Moor, apart from its historical significance as the last action fought on English soil, contains some unique tactical features – a night action with Highlanders defending hedges and enclosures against mounted and dismounted dragoons. Great scope for battlefield confusion with elements of farce, too since (in the words of a Highland prisoner), 'We gat on noo very weel, till the lang men in the muckle boots (Colonel Honeywood) came ower the dyke, but his fut slipped on a turd and we gat him down.' Try writing rules for that!

On a rather more serious note the battle of Culloden itself offers possibilities for smaller-scale table-top actions in the events of the retreat and pursuit from Drumossie Moor. The actions of the Irish Picquets, under Brigadier Stapleton, are

a case in point, and their attempts to form a disciplined rearguard amidst the wreckage of defeat would pose a challenge for any wargamer. As regular troops in the pay of a foreign king, they were, of course, entitled to expect honourable treatment under the usual conventions of contemporary continental warfare. Stapleton would have been at pains to ensure that his men did not end up being classed with the rebels, and there is scope here for a little role-play game when any surrender is being negotiated.

Strategic Level Games

While the one-off battle can be a fascinating and entertaining wargame, placing it in the context of a wider, campaign game does much more to put the players in the shoes of their historical counterparts. The Jacobite campaign in England is an ideal subject for such a game, being relatively short, well documented, and full of intriguing 'what ifs'.

At first sight maps pose a problem, since there aren't any contemporary maps suitable for wargames purposes. My own solution was to issue the players with modern road maps and tell them simply to ignore the motorways. Other major roads were usable with the following restrictions:

- (a) Single digit 'A' roads (e.g., the A6, which runs from the Border to Derby and beyond) passable in all weather conditions.
- (b) Double digit 'A' roads (e.g., the A69 Newcastle-Carlisle) passable except in snow.
- (c) Triple digit 'A' roads (e.g., the A523 Ashbourne-Leek) passable except in heavy rain.
- (d) Any other roads passable only to Horse and Foot, in fine weather or light rain only.

Doubtless such a simple method does bring some distortion, but I believe that the effects are minimal. In my own campaign this system brought Charles and Cumberland to a decisive battle midway between Leek and Ashbourne on 7 December. Given that in the real campaign Cumberland drew up his army for battle at Stone, less than twenty miles away, on 3 December there is clearly nothing seriously wrong.

Mention has been made of the effect of weather on road movement. The weather during

the course of the historical campaign was notably foul, with major consequences, in particular for the movement of the regular forces. This can be reproduced by the umpire drawing up a campaign weather diary, in advance of the action, with the weather pattern for each day pre-determined. This must, of course, be kept secret from the players, short of giving them a vague idea of what the skies look like!

Of the many points from which such a campaign game could be opened, I chose to start mine on the morning of Tuesday, 19 November. The Jacobite army is at newly captured Carlisle, making the final arrangements for the march South. Wade is at Hexham, with his troops so exhausted and demoralized that his council of war will that day decide to retire on Newcastle. Ligonier, nominally in command of an as-yet unformed Midlands army, has fallen ill, his regiments scattered between Lichfield and Dunstable. Cumberland will not be put in command until 23 November, by which time bad news from Carlisle and words of gloom from Wade should have put him in a suitably anxious frame of mind.

Wade's part in the campaign poses a problem, since it is unlikely that any self-respecting wargamer will put in as lacklustre a performance as did the ageing field marshal. The best solution is to dispense with a Wade player altogether and put his Northern army on an umpire-controlled autopilot, proceeding South by the most leisurely of marches and keeping up a stream of complaints and excuses in correspondence with Cumberland. As in the real thing, however, a flying column of cavalry, under Oglethorpe, should be allowed to cross the Pennines and join in a pursuit, once word reaches Wade of any Jacobite retreat.

Prince Charles's task is, of course, to strike hard and fast, maintaining the morale and propaganda momentum of the campaign by the very rapidity of his advance. The Jacobites' rate of march consistently upset Hanoverian calculations (as did Wade's slowness) and I would suggest that they should be allowed to march perhaps half as fast again as the Redcoats, and with fewer halts.

Cumberland's objective is rather simpler – to unite the forces in the Midlands and bar the way to London. He seems to have been keen to force

a decisive action, which was possibly a mistake since the Hanoverian dynasty might well not have survived a defeat of its soldier-prince by his Stuart equivalent. By the time of the decision at Derby Cumberland's already exhausted infantry had been wrong-footed and the force assembling at Finchley was only the nucleus of a field army, with the loyalty of the newly landed Black Watch, barely recovered from its 1743 mutiny, a wholly unknown quantity.

So, although in conventional military terms the invasion of England is a rash adventure, the Jacobites' speed advantage and the Wade factor make for a more balanced wargame campaign than might at first be imagined.

Committee Games

These may be unfamiliar to many wargamers, but they have been practised for a number of years in some wargames circles. Basically, they are a form of historical role play, in which players are given individual briefings and objectives which they are to achieve through discussion, argument, persuasion and bargaining among themselves. The '45 offers a number of possibilities for games in this format, for example:

The Council of War at Derby – The decisive moment of the campaign. Strict historical briefings will inevitably lead to Charles being massively outvoted again, so some tinkering with the situation will be necessary. In particular, Dudley Bradstreet should be exposed as a spy and his story of a third army at Coventry be exposed for the fiction it was. That way Charles might just be in with a chance of swinging the decision.

Wade's Council of War at Hexham – What can have been going through Wade's mind? Is it beyond the bounds of possibility that he saw himself in the role of arbiter of dynasties, leading an army down from the north-east to back the winner of any battle in the south? The opposition of such as Oglethorpe, who will need to be played as a fire-breathing Hanoverian loyalist, can be counter-balanced by the attitude of the Dutch commander, who will be anxious to avoid involving his troops in any military activity whatsoever, leaving the English to sort out their own politics.

The battle of Culloden itself was a very one-sided affair, so although it would make a colourful set-piece exercise (for example as a club display at a convention), it is unlikely to produce a satisfactory wargame. The '45 as a whole, however, is rich in

wargaming possibilities, and the ideas set out above are an attempt to show how the conventional table-top game with figures need not be the only focus of the more adventurous wargamer's attentions.

CULLODEN 1746

Culloden marks the end of the last and greatest of the Jacobite adventures – the '45 Rebellion. After two stunning victories over government troops and an epic march into England, the Jacobite army was finally brought to bay on the windswept landscape of Culloden Moor. Peter Harrington details this campaign and its cataclysmic end.
